# 3. Set the Agenda:

# 6. Celebration Reports

Mrs. Haukeness reported that the local Kiwanis Club donated \$1,250 to the school district lunch program to assist children with their lunches.

The district will host a HTI community dinner on February 24 at Lotsa Pasta Sheri Noyes reported that the Lewis/Arriola Elementary School Hoedown raised \$21,863. Whitney Rapp reported that the recent professional development classes for certified staff was awesome.

#### 7. Superintendent Report

Ms. Haukeness referred to her written report and asked if there were questions. She also briefly reported about the legislation that was being considered at the state level with regards to education.

#### 8. Staff Reports

**Ms. Jeanette Allen** referred to her written report. She reported on Tier III Behavior. They are collecting information on Title I Behavior. Lori said the district was working with SJBOCES to do a deep analysis on behavior in our district. Mrs. Wright commented that the Board was very concerned about serious student behaviors in our schools.

**Carol Mehesy** outlined the proposed changes with the nursing salary schedule. It is proposed to expand the current salary schedule to include LPN and RN expansion due to difficulty in hiring school nurses.

Melissa Brunner referred to her written report and had no other comments.

**Jamie Haukeness** reported on the monthly safety meeting. Regarding the issue of vaping in schools, there was an assembly at the high school and middle school. It was an outstanding presentation and well received. They hope to bring it back for  $4^{th} - 5^{th}$  graders in March. There is a large parent reunification drill scheduled.

**Ms. Tammy Hooten** reminded the Board that she represents our district on the CASB Legislative Team and has legislative updates every two weeks. She will keep the board posted on educational legislative action.

**Ms. Sonja Copeland,** French teacher at the high school, and five of her students reported on their trip to England, France and Spain. They thanked the board for allowing them to have such a great experience. Each student gave a brief personal summary of the trip and highlighted their favorite event. They presented the board with a European food and a framed photo of trip.

**Ms. Nancy Dickerson Shaw,** representing CEA, reported on the TLCC Survey and recited data concerning the survey. She reported on current Colorado state legislation regarding education and funding. She asked the board to support the Resolution in Support of Staff Retention that is item on the board agenda.

# 9. Board Requests/Reports

Mr. McDaniel reported on recent KSJD radio interviews with SWOS students. He also reported on the student youth council. Their discussion centered on allowing 16-17 year olds being allowed to vote in School Board Elections.

Ms. Sheri Noyes inquired about student handbooks. The high school is revamping theirs. Where are we with the staff/student dress code policy?
