## Presentation of IPES - F. Georgina, K. Longobucco

Fawn Georgina presented the freshman science course – Integrated Physical Earth and Space Science. NGSS standards were adopted in 2015, by the state of Connecticut. Therefore the IPES curriculum had to be updated to align with the new standards which were significantly different from the prior standards. This work started several years ago and after many disruptions was finally completed in June of 2022.

The Units are as follows:

- Labs and skills density
- Big Bang and the Electromagnetic Spectrum
- Formation and Life Cycle of Stars
- Motion of the Solar System
- Formation and History of the Earth
- Climate Change (Historical and Modern)
- Energy Resources Integrated Physical and Earth Science

### Presentation of Honors Physics – K. Lowell, K. Longobucco

Kim Lowell provided an overview of Honors Physics. Honors Physics is a course for juniors and seniors, and for some advanced sophomores. Melissa Torrence helped with the writing of the curriculum that emphasizes the science and engineering practices. Physics requires a great deal of math. Most students should have already taken Geometry or are taking it concurrently.

The Units are as follows:

- Kinematics
- Forces
- Momentum and Energy
- Rotational Motion
- Electric and Magnetic Phenomena
- Waves

#### Elementary Reading Program Update - A. Uberti

Anne Uberti presented an update to the reading program. She explained that she and Kara DiBartolo, Director of Teaching and Learning, will be presenting a recommendation to the Board on Tuesday, January 17, 2023. The recommendation will include changes that the Core Review Team arrived at since the December 8, 2022 presentation. The recommendation will be to implement EL Education/Imagine Learning

for a one year trial period in grades K through 4 as a one year trial. Specifically, the presentation will provide a rationale for implementing EL Education/Imagine Learning Module Lesson Block and Fundations and Heggerty in Kindergarten through Grade 2. In Grades 3 and 4, the recommendation will be to implement EL Education/Imagine Learning Module Lesson Block as well as their ALL (Alternative Language and Literacy) Block. This would allow teachers to receive appropriate training and allow for a true evaluation of the program over the course of the year. The presentation to the Board of Education will provide a complete explanation and rationale for why the Core Review Team arrived at this decision and for making this recommendation.

There were several questions asked by the subcommittee members that Ms. Uberti answered. She stated that answers to all of the questions that were asked would be included in the 1.17.20 presentation to the Board of Education.
