Sealed proposals will be received by Dothan City School, at Honeysuckle School Conference Room, located at 1665 Honeysuckle Rd, Dothan, AL 36305 until 3:00 PM CST for the base bids and all alternates on Thursday, June 13th, 2019 at which time they will be open and read.

### DOTHAN CITY SCHOOLS SITE WORK IMPROVEMENTS

A cashier's check or bid bond payable to Dothan City Schools in an amount not less than five (5) percent of the amount of the bid, but in no event more than \$10,000, must accompany the bidder's proposal. Performance and Payment Bonds and evidence of insurance required in the bid documents will be required at the signing of the Contract.

Project consists of minor grading and storm sewer improvements associated with drainage issues at Girard Primary, Girard Intermediate, Faine Elementary, and Carver Intermediate schools. Work shall include minor demolition, fine-grading swales and between buildings, storm sewer, grate inlets, connections of storm sewer system to existing downspouts, miscellaneous concrete, landscaping, and erosion control.
