## **Meeting Minutes**

January 9, 2012

#### I. Call to order

Paula Gallegos called meeting to order at 6:42 pm on January 9, 2012 in GJHS Band room.

#### II. Roll call

Present: Paula Gallegos, Paula Casey, MaryAnne Hoffman, Christy Lone, Tami Nicholson, Isaac Lavadie.

Absent: Kerri Mosinski, Cara Weaver, Christina Cornelison-Travis, Kathleen Hedlund, Melissa Pipkin.

### III. Approval of minutes from last meeting

Last meeting minutes were not read or approved as they were unavailable; postponed until February meeting.

### IV. Reports

- a) Thank you cards. Fall thank you cards have been mailed. Winter thank you cards are still being signed and will be sent when ready.
- b) Treasurer's report. Given by MaryAnne. Balance sheet handed out.
  - 1. Assets as of 12/31/11 = \$12,846.98.
  - 2. Have not received a check from the original bus company for the Las Vegas trip. "The check is in the mail"; however, as of Friday, January 6, 2012 it was not in the PO Box.
  - 3. Known outstanding bills: the 2<sup>nd</sup> bus company and Roper Music.
  - 4. McAlister's Fundraiser money (approximately \$262 + \$50 tips) will go into the SBA account.
  - 5. \$400 earned from GJ Symphony (in August) was deposited in SBA account.
  - 6. \$500 deposit for next Marching Band Show will be needed in March. (\$4500 approx. total cost.)
  - 7. Roughly 12 to 15 Marching Band students still have not paid their fees and only a handful of those have made payment arrangements. This results in approximately \$4600 in lost funds. This issue needs more discussion at the March meeting.
- c) Bingo Account Report. Given by Paula Gallegos. Balance sheets handed out.
  - 1. Band December Bingo balance = \$1668.45.
    - Choir December Bingo balance = \$4646.16.
    - Orchestra December Bingo balance = \$2482.75.
    - Band December 50/50 balance = \$305.25. (\$1500 was paid to Roper Music.)
  - 2. GJHS Music Parents have now picked up a second session of Bingo. Tuesday evenings.
  - 3. Melissa found a \$3000 discrepancy in the books and brought it to Deb Boch's attention. The error was corrected.
  - 4. The Bingo bookkeeper has raised her rates from \$45/session to \$60/session. These fees have been raised/paid without knowledge or consent of the board members. Needs further discussion.
  - 5. The following concerns and/or actions were a result of this report and its discussions:
    - i. Should a certified bookkeeper be hired for the Bingo account?
    - ii. The board should have 2 separate reports since there are 2 two sessions of Bingo. It would also be beneficially to see which session creates more revenue. Paula Gallegos will discuss this with Melissa.
    - iii. MaryAnne will contact the GJHS Booster Club president or treasurer to discuss who handles their Bingo bookkeeping and what their fees are.

- d) <u>Bingo Volunteers</u>: Students have done well signing up to help with Tuesday night Bingo sessions. The current scheduler will probably be leaving this May so this position will need to be filled.
- e) <u>Parent Donation Receipts</u>: Isaac will email a general receipt to Marching Band parents regarding the tax deductible fees made payable the GJHS Music Parents.
- f) <u>In The Note</u>: The next publication will be a list of important dates and descriptions sent to Isaac to post on the Band's website.
