

Minutes of the Special Meeting of October 3, 2022, held at 4:00 p.m.

١. Attendance:

a. Call to Order

Mr. Rojas called the meeting to order at 4:00 p.m.

b. Pledge of Allegiance

Dr. Varona led all in the Pledge.

Dr. Varona asked for a point of order and requested to honor a moment of silence for Prior NUSD Engineer Mr. Manuel Montaño who passed away last week. He further mentioned the highlights of Mr. Montaño's career at NUSD.

Mr. Rojas added condolences to the Montaño family on behalf of Nogales Unified School District. He further mentioned Mr. Montaño had also been a member of the Lion's Club, as well as many of the Board Members.

President Rojas by Dr. Varona's request directed Superintendent Canto to follow up with a sympathy card.

Superintendent Canto mentioned she was planning to attend the services and would take care of it.

Adoption of the Agenda C.

Superintendent Canto recommended approval with exception of Action item 6.b- Second Read of the Policies to bring back at the meeting of October 24, 2022.

Mr. Ruiz made a motion to approve the agenda with the recommended changes mentioned by Superintendent Canto and was seconded by Dr. Varona for approval.

III. Presentation and Discussion

Superintendent Canto gave an overview of the presentations scheduled for this meeting, Elementary Schools Spring Assessment 2022. She further mentioned that the data for the secondary schools would be presented at the meeting of October 24, 2022. In addition, she mentioned that the Letter Grade information was not available at this time but would be shared at the December Board Retreat.

Superintendent Canto introduced Asst. Superintendent Aissa Bonillas to begin with the District overview presentation.

NUSD Elementary Overview – Aissa Bonillas, Asst. Superintendent

Asst. Superintendent Bonillas gave an overview of her presentation and focus on the Arizona Academic Standards Assessment (AASA) Information.

Superintendent Canto thanked Ms. Bonillas for the presentation and mentioned this is something to look forward in the rest of the presentations including secondary schools.

Mr. Ruiz made comments about the difference in the 4^{th} and 5^{th} grade curriculum and mentioned it was great to see it was moving in the right direction.

Asst. Superintendent Bonillas mentioned that whatever happens with fourth graders seemed to work in a positive way to when they get to 5th grade because they do a much better job.

Dr. Varona mentioned that he has been consistent with his remarks of disagreement with the State Legislature of changing the format to test students. He highlighted the different statistics he saw in the testing of the years 2021 and 2022.

He concurred with Mr. Ruiz that the District is moving in the right direction.

He thanked Ms. Bonillas for the great presentation.

Mr. Rojas stated he agreed with both colleagues' comments and thanked Ms. Bonillas for a good presentation.

2. Mary L. Welty Elementary School – Mariebeth Silva, Principal

Superintendent Canto introduced Ms. Mariebeth Silva to give her presentation.

Ms. Silva gave a Power Point presentation on an overview of the data and school action plan.

The Governing Board made comments on the subject and Ms. Silva, and Superintendent Canto clarified all inquiries and concerns.

Challenger Elementary School – Christina Valdez, Principal

Superintendent Canto introduced Ms. Christina Valdez to give her presentation.

Ms. Valdez gave a Power Point presentation on an overview of the data and school action plan.

The Governing Board made comments on the subject and Ms. Valdez, and Superintendent Canto clarified all inquiries and concerns.

Lincoln Elementary School – Saralee Burkett, Principal

Superintendent Canto introduced Ms. Saralee Burkett to give her presentation.

Ms. Burkett gave a Power Point presentation on an overview of the data and school action plan.

The Governing Board made comments on the subject and Ms. Burkett, and Superintendent Canto clarified all inquiries and concerns.

A.J. Mitchell Elementary School – C. Gabriel Wong, Principal

Superintendent Canto introduced Mr. Gabriel Wong to give her presentation.

Mr. Wong gave a Power Point presentation on an overview of the data and school action plan.

The Governing Board made comments on the subject and Mr. Wong, and Superintendent Canto clarified all inquiries and concerns.

Robert M. Bracker Elementary School – Joshua Payne, Principal

Superintendent Canto introduced Mr. Joshua Payne to give her presentation.

Mr. Payne gave a Power Point presentation on an overview of the data and school action plan.

The Governing Board made comments on the subject and Mr. Payne, and Superintendent Canto clarified all inquiries and concerns.

7. Fco. Vásquez de Coronado Elementary School – Sandra L. Jiménez, Principal

Superintendent Canto introduced Ms. Sandra Jimenez to give her presentation.

Ms. Jimenez gave a Power Point presentation on an overview of the data and school action plan.

The Governing Board made comments on the subject and Ms. Jimenez, and Superintendent Canto clarified all inquiries and concerns.

Board President Rojas called for a 5-minute break.

- IV. Information, Discussion, and Possible Action
 - Governing Board Resolution Supporting a FY2023 Aggregate Expenditure Limit Override

Superintendent Canto gave a brief overview and stated that this item had been requested to be placed on the agenda by Board Member Varona.

Dr. Varona mentioned that this was a Resolution that was sent to all the school boards within the State of Arizona by the Arizona School Boards Association (ASBA). Adding that it was important to demonstrate to the students, faculty, staff, parents, and community members that based on the November election results, if by March nothing has been done, then by April 1, 2023, NUSD will need to cut \$7-Million out of its budget. He added that he wanted to make clear that this Board is doing everything possible to make this resolution possible.

Dr. Varona made a motion to adopt the Governing Board Resolution supporting the 2023 Aggregate Expenditure Limit Override, and that Superintendent Canto be directed to send this Resolution to our representatives at the State Legislature, to ASBA, and to the Governor's Office of the State of Arizona, and was seconded by Mr. Ruiz for approval as presented to the Board.

Mr. Lopez mentioned he was in support of the resolution and with seeking solutions for the State government.

Motion carried unanimously by members: Varona, Ruiz, Lopez, and Rojas

 Suspension of Governing Board Policy BGB Policy Adoption for Approval of Policy Advisory September 2022 for revisions to Policy JLCB – Immunizations of Students; Regulation JLCB-R – Immunizations of Students, and Regulation KDB-R – Public's Right to Know/Freedom of Information

Superintendent Canto gave a brief overview and introduced Mayra Zuñiga, HR Director, to explain further the policies.

Ms. Zuñiga explained the revisions being made to the policies with a Power Point presentation.

Mr. Rojas asked Superintendent Canto for her recommendation to the Board.

Superintendent Canto mentioned that her recommendation was that this item be a first read for the Governing Board and bring back for a second read and approval at the meeting of October 24, 2022 along with agenda item VI-b.

- Dr. Varona mentioned his personal comments to object about the revisions.
- Mr. Lopez mentioned he supported the proposal.
- Mr. Ruiz gave his thoughts of disagreement referring to the FERPA law.

Mr. Rojas mentioned the Board would follow the Superintendent's recommendation and would make a decision in the second read at the next board meeting.

V. Information and Discussion

a. Presentation of FY22 Annual Financial Report (AFR)

Superintendent Canto gave a brief overview and introduced Business Director Clementina Carlyle, to give a presentation.

Ms. Carlyle gave a Power Point presentation explaining the financial report.

Dr. Varona stated that he did not recommend draining the savings carry-over to avoid putting the taxpayers into a predicament and suggested that a presentation be given in November with options of what to do in case there were millions cut from the budget.

- Mr. Lopez thanked Ms. Carlyle for the presentation.
- Mr. Ruiz concurred with Dr. Varona and thanked Ms. Carlyle for her presentation.

Mr. Rojas mentioned that his approach on this matter is taking a conservative position and the best interest of NUSD.

VI. Action

a. Approval of FY22 Annual Financial Report (AFR)

Superintendent Canto recommended approval as presented to the Board. Dr. Varona made a motion and was seconded by Mr. Lopez for approval as recommended.

Motion carried unanimously by members: Varona, Lopez, Ruiz, and Rojas

b. Superintendent Canto gave a brief overview of the changes to the position and recommended approval as presented to the Board.

Mr. Ruiz made a motion and was seconded by Mr. Lopez as recommended.

Dr. Varona mentioned it was a great thing and specially to help those who are in need of the services.

Motion carried unanimously by members: Ruiz, Lopez, Varona, and Rojas

VII. Adjournment of the Special Meeting

Mr. Ruiz made a motion and was seconded by Mr. Lopez for adjournment of the public meeting.
