

MINUTES OF THE RANDOLPH COUNTY BOARD OF EDUCATION  
AUGUST 1, 2014  
6:00 PM

The Randolph County Board of Education met on Friday, August 1, 2014 at 6:00 pm. The Board meeting was held at the Randolph County Board of Education Central Office Board Room. The following members were present: Mr. Harold Bonner, Mr. Roger Key, Mr. Mark Prestridge, Mrs. Tammy Farr and Mr. Jerry Walker.

The Board meeting was called to order by Chairperson Tammy Farr. The meeting was opened with prayer by Mr. Harold Bonner.

Chairperson Tammy Farr asked the Board to approve the agenda. Mr. Mark Prestridge moved to approve the agenda. Mr. Roger Key seconded the motion which carried unanimously.

Chairperson Tammy Farr asked the Board to approve the minutes of the July 29, 2014 meeting. Mr. Jerry Walker moved to approve the minutes. Mr. Mark Prestridge seconded the motion which carried unanimously.

Superintendent Kirby recommended the Board go into executive session to discuss good name and character of individuals. Mr. Jerry Walker moved to accept the recommendation. Mr. Roger Key seconded the motion which carried unanimously.

Chairperson Tammy Farr requested a motion to come out of executive session. Mr. Jerry Walker moved to come out of executive session. Mr. Roger Key seconded the motion which carried unanimously.

Superintendent Kirby recommended to approve the personnel action sheet:

- 4) Recommend to approve Charles Warren Weeks as Principal of Woodland High School for a one year probationary contract effective immediately;
- 5) Recommend to approve Alton Murphy as PE Teacher at Woodland High School effective immediately;
- 6) Recommend to approve Jennifer Sanders as Elementary Teacher at Woodland High School effective immediately;
- 7) Recommend to approve Briana Medhus as substitute for Support Personnel;
- 8) Recommend to approve Tara Kennedy as Pre-K Lead Teacher at WES effective immediately;
- 9) Recommend to approve the following Interim personnel at RCHS for no more than six(6) weeks:
  - A. Jaqueline Maduro- Middle grades math teacher
  - B. Wendy Moore- Title I ACCESS Learning Facilitator
  - C. Hilary Shaw- Title I Teacher
