4. School / Community Session - 7:00 p.m.

4.1. Recognition:

4.1.1. Grace Cummings - Proclamation from the State

Superintendent Scarice introduced Grace Cummings to recognize her as the National Recipient of the NFHS National High School Spirit of Sport Award. Superintendent Scarice stated that the District can only take a small amount of credit for her achievements and that the credit really goes to Grace's parents. Superintendent Scarice presented Grace with a Proclamation from the State signed by Denise Merrill - Secretary of State, Martin Looney – President Pro Tempore of the Senate and Brendan Sharkey – Speaker of the House.

Superintendent Scarice stated the following regarding Grace.

Grace Cummings, a student-athlete at Madison (Connecticut) Daniel Hand High School, has been selected the 2015 national recipient of the "National High School Spirit of Sport Award" by the National Federation of State High School Associations (NFHS).

The "National High School Spirit of Sport Award" was created by the NFHS to recognize those individuals who exemplify the ideals of the spirit of sport that represent the core mission of education-based athletics.

Grace is described as being fearless, tenacious, self-sufficient and self-motivated, Grace is a highly accomplished three-sport student-athlete who plays field hockey in the fall, ice hockey in the winter, and tennis in the spring.

On the performing arts side, Grace has been a member of the percussion section in both the school's marching band and concert band, and she has also been a member of the flag squad.

Grace has been equally exemplary in the classroom, where as a high honor student she has maintained a glittering 3.98 grade-point average while taking all honor or advanced-placement college-level classes.

While those accomplishments are amazing in and of themselves, they are made even more remarkable by the fact that since a very young age Grace has been challenged by serious health issues related to her liver. At age 15 Grace underwent a liver transplant in 2012. Although that prevented Grace from attending school and from athletic competition for six months, she maintained both her sterling athletic and academic regimens and has now returned to full capacity.

After being cleared to return to physical activities, Grace again played her three sports, where she additionally served as captain of both the ice hockey and tennis teams.

Superintendent Scarice thanked the District's support staff for all of their hard work. 4.2. Public Participation

William Barker of 7 Hamilton Drive made the following statement.

The town spent \$100,000 to renovate the Polson gym to make it better for our kids. However, our kids can't use it in the summer because it will last longer with less wear and tear.

I find fault with that for two reasons. 1) it is not logical and 2) it is not valid. To improve it for the kids and then not let them use it is not logical. The only wear and tear is to the finish of the floor. Madison Hoop Dreams uses it after the school year is over. After our camp the gym floor is refinished to have it look like new for the next school year.

MHD has offered to pay \$200 per week or \$1,000 per summer as our share of the purported wear and tear. In addition, we will contribute \$200 per week toward a fund to be used to maintain the new scoreboards and ultimately have enough funds to replace them when needed.

Another statement is that MHD is an outside group. If that is the case, so is Madison Youth Basketball Association. We are both independent 501c3 corporations that apply to use the Polson gym through our AD. Therefore, if MHD is an outside group, so is MYBA. The administration needs to be uniform in its enforcement of its policies.

Another concern should be that parents are looking to keep their children active. MHD is the most popular camp in town. Since childhood obesity is a concern, it is not logical to take Polson offline. Why should the best indoor recreation facility not be available to the camp preferred by campers and parents?

Is that same logic going to be applied to the recently redone turf at Daniel Hand High School? No outside groups allowed?

5. Board of Education Student Representatives' Report

Ms. Fitzgerald stated how she appreciates the hard work the Board of Education student representatives put into their roles.

Ms. Wood reported on the following:

The Planning Committee met this morning with a very full agenda. The presentation on the Sister School Partnership with Lakeside International School in Guanacaste, Costa Rica that was heard by the Board earlier this evening was presented to the Planning Committee earlier today.

Ms. Wood thanked Mr. Hibbard and Ms. Mancini for their amazing research and personal financial commitment to purse the tremendous immersion learning opportunity. The opportunity for not only the students who can attend the two week session in August 2016 is tremendous, but the planning Committee was also excited to hear about the on-going opportunity that can permeate multiple classes and impact a much larger audience.

The Planning Committee is very pleased to recommend the trip and Sister School opportunity for approval by the full Board

Ms. Wood stated that the bulk of the meeting was then spent on the comprehensive facility assessment with representatives from DRA.

The study is really underway in terms of collecting data, listening to constituents and beginning to formulate potential options based on both the enrollment and its goals around schools including instructional spaces, physical space, efficiencies and equity across the district.

Art Wagman joined the Planning Committee for a second time to present the findings on enrollment. The second presentation allowed additional Board members to get involved as well as allowed a second pass at the information. The final ten year projection is based on two district models.

1) Co-hort survival rate of a 7 year historic math model based on both rates and historical migration is in and out of district by students data is provided by the Department of Education, Town Clerk and Connecticut Department of Statistics.

2) Madison model based on Madison mitigating facts such as housing influences, new construction permits, planning and zoning report that included plans regarding future senior housing.

Range of two models is approximately 2429-2617 (188 student difference -12 grades, 15 per grade). Substantial further decline in enrollment from our current 3100 students, with a flattening out of the decline.

Based on our vision and enrollment numbers we saw a first pass at five possible school configurations moving forward. The options range from do nothing all the way thru to some creative options that close buildings and redefine configurations. The options will all be spelled out to the public at a town wide meeting with DRA on May 11, 2015 where we will begin to hear public comments and get feedback crucial to hear that configuration changes would not be scheduled for a few years, likely 2019-2020.

Mr. Clorite stated that the Uniform Chart of Accounts coming from the state will not add additional work to Stacy Nobitz.

Mr. Clorite stated that the Effective Schools Solutions would be voted on later in the meeting.
