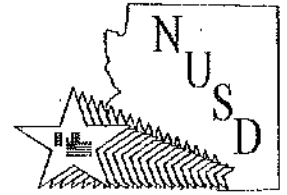

Rojas, Mendoza and Varona


III. Adjournment of the Special Session


Mr. Rojas made a motion and was seconded by Mrs. Mendoza for adjournment of the public meeting.

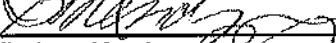

Session adjourned at 3:07 p.m.


