## Spring 2019 Immunization Update

Attention: School Nurses, Health Aids, School Site Secretaries, Student Services, Principals

### Yolo County Safety Net Immunization Clinic (See CAHAN)

1. Encourage parents to schedule immunization appointments with their providers before Summer.
2. Depending on immunization needs, the maximum capacity for our Safety Net Clinic is 6 appointment times.
  - a. Appointments are extended for children requiring a high number of vaccines.

### Changes to School Immunization Requirements

Starting July 1<sup>st</sup>, 2019

1. 2 doses of Varicella (Chickenpox) will now be required for Students starting 7<sup>th</sup> Grade as well as new admissions and transfers for all grades, including transitional kindergarten.
2. DTap(DTP, Tdap, or Td), Polio, HepB, and MMR immunization requirements will also apply to all new admissions and transfers for all grades, including transitional kindergarten.
3. 7<sup>th</sup> Grade Tdap requirement will stay the same. Please see link below for all School Immunization Updates.

### Considerations for Medi-Cal or Medi-Cal eligible Families:

1. The patient or parent/guardian should contact Partnership's member services number as this exceeds the maximum allowed time (per contract) for non-urgent primary care appointments (within ten (10) business days of request). If there is a provider shortage, Partnership is required to refer members to, or assist members in locating, available and accessible contracted providers in neighboring service areas for obtaining health care services in a timely manner appropriate for the member's needs.
2. Similarly, for members less than 21 years of age,<sup>[1]</sup> when a parent or guardian requests a preventive care visit or has a referral from the local Child Health and Disability Prevention Program (CHDP)/CHDP Gateway, Partnership shall make an appointment for the member within two weeks of the request.

Subject: Change in Yolo County Safety Net Immunization Clinic Hours

**Effective January 1, 2019 the hours for the Yolo County Safety Net Immunization Clinic will change to 2pm – 5pm for routine Monday Clinics.**

- Priority: will be given to those who schedule appointments.
- Appointment time: scheduled every 30 minutes.
- Walk-ins: welcome to wait and see if there are last minute cancellations or availability. Walk-ins will still be accepted for Flu and Tdap only visits.

## Routine Services Offered

- Vaccine For Children (VFC) Provider (Birth – 18 years)
  - Medi-Cal/CHDP Eligible
  - Uninsured (no health insurance)
  - American Indian/Alaskan Native
- Adults (Limited vaccines available. Strongly recommend calling first.)
  - Uninsured
  - Underinsured (Vaccines not covered by insurance.)
- Additional vaccines may be offered to the general public regardless of eligibility during outbreaks and pandemics.

## Services **Not** Offered

- Individuals with a high share of cost or copay for immunizations.
- Travel vaccinations
- Tuberculin Skin Tests (TST)
- Rabies Vaccinations

# PARENTS' GUIDE TO IMMUNIZATIONS REQUIRED FOR SCHOOL ENTRY



Starting July 1, 2019

## Students Admitted at TK/K-12 Need:

- **Diphtheria, Tetanus, and Pertussis (DTaP, DTP, Tdap, or Td) — 5 doses**  
(4 doses OK if one was given on or after 4th birthday.  
3 doses OK if one was given on or after 7th birthday.)  
For 7th-12th graders, at least 1 dose of pertussis-containing vaccine is required on or after 7th birthday.
- **Polio (OPV or IPV) — 4 doses**  
(3 doses OK if one was given on or after 4th birthday)
- **Hepatitis B — 3 doses**  
(Not required for 7th grade entry)
- **Measles, Mumps, and Rubella (MMR) — 2 doses**  
(Both given on or after 1st birthday)
- **Varicella (Chickenpox) — 2 doses**

These immunization requirements apply to new admissions and transfers for all grades, including transitional kindergarten.

## Students Starting 7th Grade Need:

- **Tetanus, Diphtheria, Pertussis (Tdap) — 1 dose**  
(Whooping cough booster usually given at 11 years and up)
- **Varicella (Chickenpox) — 2 doses**  
(Usually given at ages 12 months and 4-6 years)

In addition, the TK/K-12 immunization requirements apply to 7th graders who:

- previously had a valid personal beliefs exemption filed before 2016 upon entry between TK/Kindergarten and 6th grade
- are new admissions

## Records:

California schools are required to check immunization records for all new student admissions at TK/Kindergarten through 12th grade and all students advancing to 7th grade before entry. Parents must show their child's Immunization Record as proof of immunization.
