B. Specific Items of District Business which require Action

a. Discuss and request for approval a proposal for Junior Bobcat Basketball League.

This will be presented by Mrs. Micca Martinez as an opportunity for younger students to have a league experience without having to go to Camp Verde or Cottonwood.

b. Gifted Program Scope and Sequence – This is an updated plan on how Beaver Creek incorporates gifted programming into the school day.

c. Request for approval to purchase an electronic marquee from Stewart Signs.

The marquee will be attached to the wall of the library and will have 4 lines of 5.5" text. Quote is attached in the amount of \$8,320.00.

e. Discuss and request for approval of changing the full-day kindergarten program to two half day programs on January 5, 2015 due to the increasing size of the kindergarten class.

Under the direction of highly qualified teacher Peggy Mattingly with highly qualified substitute Susan Schafer teaching an extension the other half of the day, all students will receive the Arizona state required and funded half day program in either the morning or afternoon based on the recommended split by Mrs. Mattingly AND also be provided an extension of the standards the other half the day with Mrs. Schafer. Additionally a full-time paraprofessional Sheryl Winkler will continue with the students in both classes providing support for special education students.
