
6-3 INCOME STATEMENTS

WHY IS YOUR TAKE-HOME PAY (NET PAY) LOWER THAN YOUR SALARY (GROSS PAY)?

- Withhold taxes
- Social security
- Medicare
- Retirement savings
- etcetera

EXAMPLE #1

- Barbara has a new job and wonders whether or not her net pay is correct on her first paycheck.
- Her gross pay per week is \$469.75, social security withholdings are 6.2% of her paycheck, and medicare is 1.45% of her paycheck.
- According to her W-4 form, federal taxes are \$110.51, and state taxes are \$66.62.
- Her retirement savings are \$9, disability insurance is \$2.56, medical insurance is \$12, and dental insurance is \$6.

EXAMPLE #1 SOLUTION

(6.2% of gross pay)

(1.45% of gross pay)

Gross pay	\$469.75
-social security	-\$29.12
-medicare	-\$6.81
-federal taxes	-\$110.51
-state taxes	-\$66.62
-retirement savings	-\$9
-disability insurance	-\$2.56
-medical insurance	-\$12
-dental insurance	<u>-\$6</u>
Net pay	=\$227.13

EXAMPLE #2

- Examine Lorena's bi weekly pay stub to the right.
- If everything stays the same, how much will be taken out of her total annual gross salary for federal and state taxes?

EXAMPLE #2 SOLUTION

- Paycheck stub says that \$280.89 was taken out for state taxes. Biweekly means 26 times per year: \$280.89*26 = \$7303.14
- Paycheck stub says that \$1001.47 was taken out for federal taxes. Biweekly means 26 times per year: \$1001.47*26 = \$26,038.22
- Therefore total annual taxes taken out of her annual gross salary
 - = \$7303.14 + \$26,038.22
 - =\$33,341.36

Federal taxes

+ State taxes

+ Local taxes

=Total income taxes withheld

\$15,851.00 +\$5,344.50 <u>+\$1,092.00</u> = \$22,287.50
