What IS A TITLE I School?

- ▶ Being a Title I, Part A school means our school is receiving federal funding (Title 1, Part A dollars) to supplement the school's existing programs. These dollars can be used for...
 - ▶ Identifying students experiencing academic difficulties and providing timely assistance to help these students meet the state's challenging content standards
 - Purchasing supplemental: staff, programs, materials, and supplies
 - Conducting parent and family engagement meetings, trainings, and activities

1% "Set-Aside"

- ► Any local education area (LEA) with a Title I, Part A allocation exceeding \$500,000 is required by statute to set aside 1% of its Title I, Part A allocation for parent and family engagement.
- ▶ Of that 1%, 10% may be reserved at the LEA for system wide initiatives and administrative expenses related to parent and family engagement
- Of the 1%,90% must be allocated to the Title I schools in the LEA to implement school-level parent and family engagement
- ► Title I parents have the right to be involved in the decisions regarding how these funds will be used for parent and family engagement activities

Single Plan for Student Achievement

- ➤ Single Plan for Student Achievement address how the school will use Title I, Part A funds within the school site. Topics include:
 - ► High-quality student academic assessments
 - Supplemental services to assist struggling students
 - Coordination and integration of federal funds and programs
 - Strategies to implement effective parent and family engagement
 - ► Title I parents have the right to be involved in the development of these plans

Parent and Family Engagement Policy

- The policy addresses how the school will implement the parent and family engagement program. The policy includes:
 - Convening an annual meeting
 - Provide a number of meetings
 - Involve parents in an organized, ongoing, and timely way, in the planning, review and improvement of the parent and family engagement program
 - Provide timely information about parent and family engagement activities
 - Provide information to parents about curriculum and assessment
 - ▶ If requested, provide additional meetings with parents to discuss decisions for the education of their child
 - Title I parents have the right to be involved in the development of the school policy

School-Parent Compact

- ► The school-parent compact is a written agreement...
 - ► That addresses high-quality curriculum and instruction
 - ► That describes how parents and families, school staff, and students share the responsibility for improved student academic achievement
 - ► That stresses the importance of frequent communication between school and home, and the value of parent-teacher conferences (required in elementary schools)
 - ► That affirms the importance of parents and families in decisions relating to the education of their children
 - ➤ Title I parents have the right to be involved in the development of the school-parent compact

Teacher Qualifications

- Schools are required to notify parents that they have the right to request information regarding the qualifications of their child's teacher
- Parents must follow the school procedure to request this information
- Check with our school or district office to make this request

Annual Evaluation

- ► The content and the effectiveness of the Parent and Family Engagement Policy must be evaluated annually
- Identify barriers to participation in parental engagement
- Data and input might include...
 - Parent questionnaires and surveys
 - School Site Council and English Language Advisory Committee input
 - ▶ Report findings to parents and families and use those results to revise the Parent and Family Engagement Policy and School-Parent Compact

School Site Council (SSC)

- ► What is the SSC?
 - ➤ A School Site Council (SSC) is group of teachers, parents, administrators, and interested community members who work together to develop and monitor a school's improvement plan.
 - ► The SSC determines the focus of the school's academic instructional programs.
 - Develops and oversees Title I Parent Involvement Policy and Home-School Compact.
 - ▶ Develops and oversees the Comprehensive School Safety Plan.
 - ► Meets at least 8 times a year.
- SSC Elections- Emailed on-line ballot needs to be completed by Wednesday, Sept. 23rd.

English Language Advisory Committee (ELAC)

- What is the ELAC?
 - ► The ELAC is a committee for parents or other community members who want to advocate for English Learners. The ELAC acts in an advisory capacity. It is not a decision making body.
 - Advises on the development of services for English learners in the Single Plan for Student Achievement (SPSA).
 - Assists in the development of the school's needs assessment.
 - ► Has representation on District English Language Advisory Committee.
- ► ELAC Election- Emailed on-line ballot needs to be completed by Friday, Sept. 25th.
