PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. The United States Department of Education **does not** consider the following to be an allowable use of ESSER funds, under any part of 18003: 1) subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs or 2) expenditures related to state or local teacher or faculty unions or associations.

How will the LEA determine the most important educational needs as a result of COVID-19?

District school administrators were polled for input on needs they have encountered during the COVID19 season. Additionally, an up to date review of available school student devices was conducted. Following this, a meeting of district staff (directors and coordinators) was held to review the identified needs for schools and the district and develop a prioritized list of expenditures for CARES Act Funding. Gadsden City Schools will utilize CARES Act funding to ensure all students will receive equitable, quality instruction in the school classrooms and/or virtually using one to one devices, several on-line instructional platforms and assessment tools purchased by the district. There will also be 2 social workers, 2 mental health workers and 2 reading coaches to address the gaps resulting from COVID-19.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Gadsden City Schools will utilize a day one diagnostic to assess learning gaps for all students. Once the data has been collected and reviewed teachers will develop lesson plans designed to remediate critical standards not mastered by all or most students during whole group instruction for the first 3 to 6 weeks of the school year. For students who continue to show learning gaps following initial review and remediation. Rit tier it and tier it meetings and a plan of action will be formulated for each student failing to meet proficiency standards on benchmark assessments. All schools will continue to conduct monthly data meetings and provide ongoing progress monitoring using DIBELS, STAR Renaissance, USA Test Prep. and other benchmark assessments to track student progress and provide ongoing small group and one to one intervention using evidenced based instructional resources to bridge the learning gaps.

What is the LEA's proposed timeline for providing services and assistance to students and staff?

Plans are for student devices and needed home access to be available for students in the Fall of 2020. Social workers and supplemental counselors, additional ESL teacher, and reading coaches will also be available Fall, 2020. Instructional software will be available immediately. Cleaning supplies and devices will be available Fall, 2020, depending on availability. Special education specific adaptable devices and supplies will be available Fall, 2020. All expenditures will be expended by September 30, 2022.

How will the LEA use ESSER funds to promote remote learning?

Key expenditure items that specifically address remote learning include one to one student devices that will facilitate a virtual learning environment for all students, K-12, in Gadsden City Schools, instructional software, and Special Education devices.

3. Equitable Services Assurances

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- Purchase PPE supplies for school staff

- Chrome books for students to accommodate school attendance choice
 Laptops for students to accommodate school attendance choice

 Instructional materials almed at addressing student needs brought on by school closure
 Proposed timeline for services and assistance implementation is March 16, 2020 through September 30, 2021.

4. Other Assurances and Certifications

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- The LEA that receives ESSER funds will, to the greatest extent practicable, continue to compensate its employees and contractors during the period of any disruptions or closures related to COVID-19 in compliance with Section 18006 of Division B of the CARES Act. In addition, LEAs that accept funds will continue to pay employees and contractors to the greatest extent practicable based on the unique financial circumstances of the LEA. - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
- (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public:
 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities:
- (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
- (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
 (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

- (a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

- (d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?

Several budget items are included to address overcoming barriers. These include devices for all students, home internet access for those without it, an additional ESL teacher to support that population, Special Education adaptive devices and equipment and related services to support our special education students. In addition, counseling support will assist with outreach to our at-risk student population and those struggling with loss and emotional distress resulting from the effects of COVID19. If any other barriers arise in our district they will be addressed immediately.
