- b) Specific Items of District Business which require Action
 - i) Request for discussion and for approval for 7th grade to attend a STEM Day at Chase Field in Phoenix.
 - ii) Discussion Only of Final Allocated FY23 Budget. This item will be brought back to the Governing Board in May to approve the final budget revision per statute. As presented in February, Arizona Department of Education (ADE) Average Daily membership (ADM) reports are used to balance the allocated funds. The revision must be competed yearly before May15.
 - iii) Request for discussion and approval of allocating up to \$250,000 of district carryforward funds to begin the Grating and Drainage Project. At the time of the Board agenda posting, the district had not received approval for the \$2,229,908 construction project from the School Facilities Oversight Board.(The assessment and design phases have been completed and funded by SFOB.) As shown in an SFOB letter from last year, the district administration requested that the district accept the partial cost to keep the project moving while awaiting the new fiscal year and legislative approved funds released. These funds were then released in July and there was no cost to the district. The Contractor has stated that they will risk loss of the project costs if the district accepts \$250,000 ONLY if the Legislature approves no funds for next year.
 - iv) Request for Discussion and Approval of accepting the bid for the Lighting Project to replace Interior florescent lights with LED lights. Working with US Energy, a 1GPA contract, the district has been given a proposed project cost for classrooms, gym, ,admin, cafeteria, and other spaces of \$60,083.00. APS rebates will reduce this amount to \$53,076.00; the district is requesting to put \$15,000.00 down in FY23 and finance the remainder for 5 years as presented in option 3. The rates that

are provided may fluctuate and will be brought to the board for ratification if there is a change.
