SUPERINTENDENT'S UPDATE

Chairman Belden, on behalf of Superintendent Barile, read the Superintendent's report. Mr. Belden honored Rosemary Sarsfeld and Dottie Miles who passed away earlier in the week. Both were teachers in the district and leaders in the Brookfield community. He gave an update on COVID and spoke about the special Board meeting held on 2/14/2022. Chairman Belden also reported on the annual CT MLK Essay Contest (we had a winner from Brookfield-one of only 15 students in the state to be recognized for their essay honoring Martin Luther King Jr. Congratulations to Lydon Tessier.) and the College Board, CT Women in Science Award (Brookfield High School Earned the AP Computer Science A, Female Diversity Award Recognizing the Closing of the Gender Gap in AP Computer Science A.) Mr. Belden read the update on school security planning and enhancement and parent engagement.

SUBCOMMITTEE REPORTS

Special Finance- 1/17/2022- Mrs. Fernandes said the subcommittee discussed the operating budget at its meeting on 1/17/2022 and approved the Superintendent's proposed budget. At its special meeting on 1/24/2022, the subcommittee discussed the transportation bid award.

Policy/Communications- 1/19/2022- Mrs. Brooks said the subcommittee spent the bulk of its meeting discussing the School Library Media policy. The subcommittee voted unanimously to amend the language to Regulation #1330 to add the Boy Scouts and Girl Scouts to groups who are considered no charge.

Facilities- 2/3/2022- Mrs. Greenstein said the subcommittee discussed the School Dude reports and received an update on the WMS water, capital projects and the WMS wall. They discussed the building condition study and received a custodial staffing update. Mr. Belden gave a brief update to the subcommittee regarding the Town's ARPA Grant committee.

CAPE- 2/9/2022- Dr. Murphy said the subcommittee discussed the book challenge. Deanna Pearson was at the meeting to answer questions and they discussed guiding principles for removal. They also discussed the Candlewood Lake Elementary School library set up.

Equity & Inclusion- 2/10/2022- Mrs. Foster said the subcommittee members dedicated their time to providing each other with peer feedback on the Teacher Quality and Stakeholder Equity presentations.
