PRESENTATION OF AWARDS

There were no awards presented

Mr. Hennessey explained that he is going to read, for the record, the letter that he sent to Mr. Lubee in response to his concerns expressed at the last Board meeting. He read:

"Dear Mr. Lubee: This is in response to your recent inquiry regarding the above subject matter. As I stated to you at the Board of Education meeting on Monday, September 17th, our attorney has advised us that the Board's policy BBB, dealing with conflicts of interest and nepotism, is more stringent than the provisions of the Town of Wallingford Charter and Code of Ethics. This is due to the fact that the Board of Education is <u>prevented</u> from hiring anyone from the "immediate family" (as defined in Policy BBB) of a Board member. This is contrasted with the Town's Code of Ethics and Charter, which would merely require that a Town officer "disqualify himself or herself from voting or acting on such matter." The relative of the Town officer could still be hired by vote of the remaining members of the particular agency, commission or board of the Town. You have also brought up concerns that the Board's policies in certain respects are not as stringent as the Town Charter and Code of Ethics. I believe you may have stated that the Board's Code of Ethics "ought to be in harmony with that of the town." Our policies already are in "harmony" with the Town's charter on this subject.

I refer you to Policy BBF, School Board Member Ethics, which states the following at the ending portion of the policy: Each Board member will also comply with the "Ethics and Conflicts of Interest" section of the Charter of the Town of Wallingford, Connecticut. Our Policy BBB also cites as a legal reference the Town Charter, Chapter XVII, Ethics and Conflicts of Interests. In summary, I certainly appreciate your concerns regarding the ethical standards applicable to the Board of Education members. I hope you now understand the full scope of our policies and the standards by which I and my fellow Board members are bound. Contrary to what you suggest, we believe that there is no need for revision of the Board policies since they reflect the Board's own pronouncement on the matter of ethical conduct and they incorporate the Town's standards as well. Please feel free to contact me if you have any further questions."

QUESTION AND ANSWER SESSION

Ann Verrone- Lederle, 85 Montowese Trail, came before the Board to express concerns that the master calendar has not been distributed to parents for a couple of years ahead.

Mr. Wilson reported that the calendar has been approved for two years at a time, this year and next year. He said that sometimes the calendar is held up due to negotiations.

Mr. Votto asked how many WEA representatives there are on the calendar committee.

Mr. Harkawik reported that there are three WEA representatives plus himself.

Pat and Dave McClary, 36 Johnson Road, came before the Board with their concerns about the students driving using the back gate at Sheehan. He had a petition signed by neighbors. He reported that they have contacted the police about the situation. They requested that a gate be put up at the end of the property.

Greg Colonese, 33 Johnson Road, came before the Board to say that he has two young children and fears for them because the cars speed down the road in front of his house.

Mr. Wilson reported that he spoke to Mrs. McClary about a week ago. He also spoke to the police and they will have an officer at the driveway at 2:00 every day starting on Tuesday, October 16th. He said the security guard will also be patrolling and will take license plate numbers and the students will loose their parking privileges. He also spoke to Mr. Novak who will have the speed bumps built up to slow the cars down.

Mrs. McClary said she has spoken to the police department, the principal, and Mayor Dickinson and nothing has been done.

Mr. Wilson expressed a concern that if a gate is installed it would be vandalized as all the others have been.

Mr. Laffin suggested that he look into grading as they do in Florida.

Mr. Hennessy said this is the first time that the Board is hearing about this situation. Mr. Hennessy suggested that Mr. Wilson check with the police and fire department to see what could be done with a gate and invited the McClarys back to the next Board meeting for an update.

Mr. Laffin read the motion into the minutes. "The Wallingford Board of Education in recognition of the current and continued interest of students from the surrounding districts to participate in the Regional Vocational Agricultural Center at Lyman Hall High School and in recognition of providing the necessary space to accommodate those students hereby agrees to support the enrollment of that Center over the next 8 years to a level of up to 340 students.

The increased enrollment will commence in the school year 2009-10, be it further agreed that the Wallingford Board of Education is committed to increase proportionately, certified, vocational agriculture staff to a 35 to 1 student to teacher ratio as student enrollment continues to increase."
