QUESTION AND ANSWER SESSION

Terese Oneto, 14 Harnish Lane, came before the Board to ask when school will begin and end for the 2010-2011 school year. She also had a concern about the CMT test results.

Dr. Menzo explained that item is on the agenda tonight and parents were told they would get this information in the middle of July.

Mrs. Trutneau, 328 Pond Hill Road, came to the podium to express her concerns about the number of paras and teachers who were laid off and asked how much the reconfiguration of the school district is saving the district.

Mrs. Guarino-Rhone explained that 21 teachers were laid off but during this meeting there will be a recall list read with names of teachers who are being asked to return. She reported that two teachers were brought back already and by the end of the week there would be at least one more brought back. She also explained that there would be four people brought back who were full-time and will take part-time positions.

Dr. Menzo explained that through attrition and retirements the total number of positions was reduced.

Dr. Menzo reported that the moving expenses were \$80,000 instead of the \$150,000 that was first reported. He also said that the total gross savings for reconfiguration would be about one million dollars but that figure hasn't been finalized yet. He explained that the \$200,000 savings reported during the budget process was the net savings of reconfiguration versus the laying off of teachers. He went on to say that there was an analysis done and it was found that the bell schedules needed to be changed. He said this item is also on the agenda for approval.

Update on Strategic Planning Process

Mr. Cei explained that there were many focus groups of parents, teachers, students, etc. who met. He reported that core groups were established made up of constituencies from the town. He went on to say that surveys were sent to parents, teachers, students, and the business community members. Eighteen people representing different constituencies met for three days to create a vision and then broke into three groups to follow-up. He said they are in the Discovery stage or the first stage.

Dr. Menzo said the first draft of this vision will be presented to the Board at the October Instructional Committee meeting. He explained that there will be five more opportunities to meet with the core group which plans to investigate ways to re-engage all facets of the community.

<u>OPERATIONS COMMITTEE</u> Report on Operations Committee Meeting

Mr. Brooder said there was no report for this meeting.

<u>Update on School Year 2010-2011 School Day Schedules</u>

Ms. Winters presented that the consultant found that there were routing inefficiencies. He found that the bus routes were too long at the middle schools and elementary schools. He also found that the bells at those schools were too close together. She said at the high schools the bell would ring five minutes earlier at 7:30 a.m. and students would leave at 1:55. She reported that the middle school students would start at 8:00 a.m. and leave at 2:25 and the elementary students in grades 3-5 would start at 8:55 a.m. and leave at 3:30 with the grades K-2 starting at 9:10 a.m. and leaving at 3:35 p.m. She explained that we are using the bus fleet more efficiently.

Dr. Menzo reported that it will be adding 15 minutes to the afternoon time from the middle schools run to the elementary schools.

Ms. Winters reported that people involved in revising the schedules were Dr. Menzo; Maryann Croce, Transportation clerk; Sean Broderick, Durham Vice-President of Durham; Andrea Rummerman, Megan – routing specialist, Debbie who does the bus routes along with Simone, Randy Stewart – Treasurer, Durham Bus Company and Lou Bufardo – consultant, and herself.

Update on Approved Projects

Dr. Menzo reported on projects that were completed this summer.

- Bleacher repairs at Moran and Lyman Hall are completed, Dag Hammarskjold will be finished within the next two weeks.
- Sidewalk at Moran
- Senior Court at Sheehan High School is complete
- Playscape updates will be completed within the first two weeks of August
- The HVAC in all systems have been completed
- Asbestos Abatement at Lyman Hall has been completed
- Harvest Park elementary at Yalesville is in process and ahead of schedule
- Video Access monitoring has been done at Lyman Hall and will be installed at all elementary schools and then the middle schools
- Lighting retrofits will begin in August

He reported that we are right on schedule with all the projects that were scheduled for the summer.

- He reported that the moves for two pairs of elementary schools are completed and the rest of the moving remains.
- Interviews for the Yalesville Principal are being done
- The CMT and CAPT scores came in and were sent to all Board members. He said there have been some increases. He reported that there is growth being made. He said we have also started our building analysis. He announced that the initial CMT presentation is scheduled for September and then in October. He said staff is in the process of compiling data.
- Energy efficiency with the Sheehan project and NEXGEN is in process.
