This includes, but is not limited to, the actions of Homeland Security, Government or Law Enforcement Agencies and imposed requirements of the COVID 19 Pandemic. The district will not be responsible for the funds lost due to a trip cancellation.

5. Superintendent's Update

- Welcome
 Student Representative Matthew Elwell; Rebecca Dorsey
 (who is not with us tonight due to a college course she is
 taking;) and Zachary Oemcke
 New Board Member, Lou Zbuska
- Great Opening Week of School
 - Each school had activities set up to help students feel comfortable and to help transition back;
 - At all grade levels, the district is working to reset the norms of how school runs to return to normal;
 - Teachers and Administrators are focusing on the following: Behavioral Expectations; Academic Expectations and Academic Rigor
- <u>Transportation</u> Elementary Bus Issues Expected based on the new runs and protocols that were created due to reconfiguration. Thank you to Mr. Tencza, Mrs. Loveland, Mrs. Turner, Sherry Hoag and members of the bus company and the entire faculty and staff. The issue is much better and the district is exploring alternatives to shorten the time students are on the bus.

<u>Athletic Events and Transportation</u> – Transportation will be difficult to schedule due to the shortage of bus drivers. This problem is not just specific to our district but rather all over the state. The district's Athletic Directors are going to be working with the bus company and securing alternative transportation to create a schedule that will avoid as many busing issues as possible.

- <u>COVID Update</u>
 - Mask mandate will expire on September 30th.
 - The district is still waiting direction from the State on what will occur after the September 30th date expires. Once information is received it will be shared.
 - Mask Guidelines at Athletic Events The CIAC is leaving it to the discretion of individual districts on how they would like to proceed. The district will align itself with the Berkshire League. For fans at indoor sports, all spectators will be required to wear a mask. For fans at outdoor sports, masks will not be required.
 - Up to this point in time, there has not been a case that has impacted the schools. There have been cases but no close contacts and no quarantines that are related to the schools. If and when there are, Mr. Falcone will send out communication to the Board, parents and community.
- Regulation for Mandatory Vaccinations September 27th
 - Summary of guidance shared by the district's attorneys in regards to the September 27th mandatory vaccination was summarized and sent out to the entire faculty and staff on Tuesday evening September 7, 2021
 - Any religious or medical exemptions and any individual refusing to be vaccinated would need to complete the appropriate paperwork and inform the Superintendent in writing by September 15th.
 - Unvaccinated employees will be required to test weekly and submit their results to their school nurse. PCR or a Rapid Test and proof and evidence of results of Friday of that week in order to return to work the following week. These rules are legal, binding rules that we need to follow as all school districts. If you do not follow the guidelines, you may not be employed by the district any further.

Matthew is a senior at Terryville High School, Treasurer for the Class of 2022, and President of the Student Council. He has participated in band for 4 years. He will be reporting on sports. Volleyball, Boys' and Girls' Soccer, Golf, and Cross Country have practices. Scrimmages and competitions began today, September 8th.

Rebecca Dorsey - Absent (report given by Matthew Elwell)

Rebecca is a senior and the current Vice President of the Student Council. She is also the President of the Leo Club, National Honor Society, Secretary of the Class of 2022 and Editor of the school newspaper. Her favorite subject is English and she is an English Intern at the high school. She is also taking a creative writing course at Tunxis Community College. She enjoys art and hopes to leave a positive impact on the school and the community through her leadership and community service. The week prior to the students returning to school, seniors were able to paint their parking spots, further cementing and continuing the tradition that was started last year and bringing color and personality to the high school's parking lots.

After a year and a half of massive changes to the school environment, seniors, being the only class to have experienced a full normal school year, are needed to step up and lead to rebuild the high school norms and school culture.

Zachary Oemcke

Zachary is a Junior at Terryville High School and is Secretary/Treasurer of the Student Council. He has been a part of the high school band and marching band for 3 years and has played many of the brass instruments since the 6th grade. He enjoys painting and outdoor activities, especially competitive kart racing around the North Eastern part of the United States and has does this since he was a child.

Zachary shared with the Board how this school year has started off for him. Great in his opinion. The first day of school was exciting and a surprising thing to experience. Beginning on the second day, everyone seemed to have returned into the swing of things and were easily able to make their way to all of their classes. The idea was raised, at a Student Council Meeting, that having everyone back into the building again may be difficult and provide certain challenges. Based on the first week of school, these concerns were evaporated and he is looking forward to a great 2021 - 2022 school year.

- Class Officer Elections are ongoing. Election will be on September 17th.
- The 4th Annual Suicide Prevention Campaign. September is National Suicide Prevention Month. Students will be receiving information regarding positive mental health tips and suicide prevention education. This year's campaign concludes with the Suicide Prevention Rally and Walk which will take place, rain or shine, on Saturday, October 9th. Participants will meet and rally at the high school in the parking lot at 9 a.m. and decorate their cars. <u>Mrs. Johnson</u> – Asked if the teachers had any input on this motion and if their opinions were brought forward because we did not get this from our session last month. How do the teachers feel about this? This affects them.

<u>Mr. Falcone</u> – This does affect them. I do not know if this went to teachers or not. I believe it went to the Board to make a decision on whether they wanted to move forward with changing the policy with electronic devices. I do know the administrators took a look at it and there were two options that they were provided. This is the option they decided to go with. I cannot say if they were creating this policy from scratch and that this is what they would have chosen entirely. But, I think looking for consistency in our schools that is kind of what was presented to them. I don't know if that answers your question or not.

<u>Mrs. Johnson</u> – It does but it's not necessarily what I wanted to hear. Is there any possibility that I could put one of our high school teacher's on the spot and ask how he feels about it or how they feel about it? I don't even know if you've seen it. I'm just concerned we did this in a siloed and we did not get input by the right people.

<u>Mrs. Kulesa</u> – I completely agree. I say things like that all the time. You know that, the people that this effects the most other than, of course the students, should have input in the decision making or at least in the policy as written.

<u>Mrs. Candrea-Florenciani</u> – I know at least for the middle school; my daughter did hear about the new rule. She was not very happy about the headphone part so I know it did get told somehow someway to the kids about cellphone and earphones at least in the middle school because my daughter came home complaining about the headphone part.

Mrs. Johnson - They have been told this before we even

Mrs. Kulesa - Well they probably were told it might be coming.

<u>Mrs. Johnson</u> – But again, that is what the students are saying. What are the teachers saying about this? I'm thinking some of the teachers actually allow them to use their phones for certain.

Mr. Falcone – So, originally the policy that, there were two policies that I was asked to sort of create. One was almost a zero tolerance with no phones in the classrooms at all. If they are seen they are taken and returned at the end of the day, no phones at all. The second policy which was the one that I would say that Mike Hults and Angie Suffridge were more in favor of, was while the teachers are basically teaching the class, the students would not have phones out and then at the teachers' discretion they can have phones out. Some examples that I have worked with them on in speaking with them were in Miss Ritchie's class in the high school, if you are working on an art project it's okay to have your buds in and be working or if you are working on a creative writing piece that is fine. Truly, when the teacher is speaking, out of respect to the teacher, earbuds should be out. Your focus should be on the teacher. So, that was the hope with the wording of that document.

<u>Mrs. Johnson</u> – And I will agree with that piece, absolutely they should be paying attention to their teacher; again, I don't want to do this in siloed and that is what I have a problem with.

<u>Mrs. Kulesa</u> – I think it leaves enough discretion to the teachers where if they feel that it's not a distraction for them, they make that personal decision I would imagine. I don't think anyone is going to be walking around and saying why are you letting them having them out. I would not imagine that would be the case. As an elementary school teacher, this is not something that I deal with so I'm not really sure how they would really feel about it.

Mrs. Candrea-Florenciani - The second part is a big issue is the video recording and tick-toc.

<u>Mrs. Johnson</u> – I agree with that too, 100%. Again, I agree with everything we have here, I just do not want to this without having the people that this effects the most be on board and understand that this coming down and guess what we are changing our policy and tomorrow morning this goes into effect.

<u>Mrs. Kulesa</u> – I guess I would also say to that, if we make the decision, if we go through with it, it's a policy it doesn't mean we cannot revise it at a later date if needed.

Mrs. Johnson - Just voicing my concern.

Mrs. Kulesa - Any other questions, or concerns? Hearing none, we will move to the vote,

all in favor, any opposed, any abstentions, motion carries.
