- February 1784 first American ship sailed to China.




U.S. EXPANSION IN NORTH AMERICA



- 1840s Americans began searching for guano (bat or bird excrement) throughout the Caribbean and the Pacific to use as an agricultural fertilizer and as a primary source of saltpeter for gunpowder.
- 1850s private, economic interests in <u>trading and excavating natural</u> resources became the primary motivation for U.S. movement into the <u>Pacific Ocean.</u>

Brief History of Hawaii


- In the late 1820s, the first Americans began to settle in Hawaii when <u>Presbyterian and Congregational missionaries founded schools</u> to convert and "Americanize" Hawaiians.
- By the 1840s, <u>sugar plantations began</u> to grow in Hawaii. <u>Prices of</u> <u>sugar</u> skyrocketed during the American Civil War.
- American plantation owners struggled for political power in Hawaii in order to ensure <u>favorable tax policies on their sugar.</u>





- 1893 Hawaii's monarchy was <u>overthrown when a group of</u> <u>businessmen and sugar planters</u>, with the help of the <u>U.S. Navy</u> forced Queen Liliuokalani to abdicate.
- 1900 Hawaii became an official territory of the U.S.
- 1959 <u>Admitted as a state</u>






Brief History of Alaska

- Controlled by <u>Russia from the late</u> <u>1700s to 1867.</u>
- Acquired by the United States from Russia in <u>1867 as a territory for \$7.2</u> <u>million.</u> (approx. 2 cents per acre)
- Critics of the purchase believed the land had nothing to offer. However, the discovery of gold in the 1890s created "gold rush"
- Admitted as a state in 1959
