## **New World Language textbooks: Liz Spencer & Mark Jewett**

◆ ***Temas***. – Vista Higher Learning, 2014 to be used in our new AP Spanish course at BHS

In addition to the textbook selection/evaluation summary form submitted by Ms. Spencer, the textbook also includes access to on-line resources, is aligned to the AP (Advanced Placement) themes, includes authentic documents and is compatible with the iPad.

The CAPE sub-committee recommended the following actions:

- CAPE is recommending with Susan proposing and Victor seconding that the BOE approve ***Temas*** textbook for purchase for our World Language program at BHS.

◆ ***Realidades***. – Pearson Publisher, 2014 to be used in our Spanish 2 Honors course at BHS

In addition to the textbook selection/evaluation summary form for this replacement resource submitted by Ms. Spencer, there is also access to on-line resources and listening activities. The text is aligned to an earlier textbook in this series already in use in the high school World Language program and the text is also aligned to the AP (Advanced Placement) themes. This book includes authentic documents and is compatible with the iPad.

The CAPE sub-committee recommended the following actions:

- CAPE is recommending with Susan proposing and Victor seconding that the BOE approve ***Realidades*** textbook for purchase for our World Language program at BHS.

◆ ***Promenades***. – Vista Higher Learning, 2014 to be used in our French 2 Academic & Honors courses at BHS

In addition to the textbook selection/evaluation summary form submitted by Ms. Spencer, the textbook also includes access to on-line resources, is aligned to the AP (Advanced Placement) themes and the ACTFL (American Council on the Teaching of World Languages) Common Core, and is compatible with the iPad.

The CAPE sub-committee recommended the following actions:

- CAPE is recommending with Susan proposing and Victor seconding that the BOE approve ***Promenades*** textbook for purchase for our World Language program at BHS.

## **New Social Studies textbook: Joe Sapienza & Mark Jewett**

◆ ***America's History***. – Bedford/St. Martin's, 2014 to be used in our AP United States History course at BHS

In addition to the textbook selection/evaluation summary form submitted by Mr. Sapienza, the textbook is aligned to the **new** AP (Advanced Placement) United States History test.

The CAPE sub-committee recommended the following actions:

- CAPE is recommending with Susan proposing and Victor seconding that the BOE approve *America's History* textbook for purchase for our Social Studies program at BHS.

**New On-Line Finance Course proposed by BHS in partnership with Education Connection: a pilot program for the Spring of 2015 by Sue Troupe & Mark Jewett**

The funding for this new on-line pilot course is the result of an award to BHS of a Perkins Innovation Grant. This is a personal finance course that will enable our students to make better financial decisions.

The CAPE sub-committee recommended the following actions:

- CAPE is recommending with Susan proposing and Victor seconding that the BOE approve the *On-Line Finance Course/pilot* for the spring of 2015 at BHS.
