Distance Learning

We will be using Google Classroom for the duration of Distance Learning. Students will automatically be added to my Google Classroom once they are placed into my class through school scheduling. Google Meets will be used for Live Lessons. The link for Google Meets can be found at the TOP of our Google Classroom Page. Assignments will be posted & turned in through Google Classroom. Live Lesson assignments will serve as a confirmation for understanding the material. Students will be given specific assignments to show what they learned, present their work, & receive feedback to help progress their knowledge. Tests & quizzes will be given through Live Lessons via Google Classroom. Specific test instructions will be given on the day of the test such as unmuting themselves, timed test/quizzes, etc.

Class Rules

- Students will respect the teacher and all fellow classmates at all times. Students must be following Distance Learning Expectations & Policies, if not they may lose participation points and may result in proceeding with my disciplinary plan.
- Cell phone, music players, and game system use is absolutely NOT permitted during Distance Learning lecturing (Students must be following Distance Learning Expectations & Policies)
- If you are going to miss a scheduled exam, attendance needs to be EXCUSED. If it is not excused, you
 will receive a ZERO. Please inform me BEFORE missing the exam so we can arrange a time during my
 Office Hours for you to make up the exam.

Late Work Policy:

You will have one day to turn in late work for partial credit. After that, it will no longer be accepted. One Day Late: 50% Max Assignment Grade

Disciplinary Plan

Please read the following carefully. Students misbehaving in the classroom environment will be subject to the following disciplinary actions:

First Offense: Student will receive a formal verbal warning.

Second Offense: Student will have a one-on-one conference with the teacher and an email will be sent to the parent/guardian.

Third Offense: Student will complete an in-class personal behavior evaluation and a one-on-one conference with the teacher. The teacher will also email the parent/guardian and inform them that this is the third and final offense before being sent to administration

Fourth Offense: The student will be ejected from the classroom with a referral to Administration, which may result, but is not limited to, a class suspension.

Please note: If a student poses a threat to the safety of the classroom, or displays extreme levels of unacceptable behavior, this may result in an automatic detention, referral to administration, or a suspension.

Cheating/Academic Dishonesty

Any student who is caught cheating, plagiarizing, or breaks the code of academic honesty will automatically receive a referral to administration and receive a zero on that assignment/test. Copying work, giving work to be copied, improving someone's score on peer evaluation, and violating test conditions are all forms of cheating. Academic dishonesty will become part of a student's permanent record, which may result in a guidance counselor or teacher not being able to write a letter of recommendation for colleges. During testing students phones will be on the desk and turned OFF. If it goes off the student will receive a zero.

Distance Learning Policies:

- 1. Do not share your district login information.
- 2. Make sure you are ALWAYS using your student email when contacting teachers.
- 3. Students will need to be visible throughout the whole Live Lesson. During Live Lessons attendance will be counted multiple times throughout the session. If a student is missing for any attendance check that period, they will be marked absent for that day.

Obviously issues may arise during Distance Learning. If issues occur, please email me ASAP along with CC'ing your parent/guardian.

- 4. Throughout Live Lessons students should be on Mute. The teacher will inform students when to unmute themselves throughout the Live Lesson for attendance, participation, presentations, and more.
- 5. Students should not be taking pictures or recording throughout Live Lessons. The teacher will be recording all lessons that will be available to students upon request.
- 6. Students may leave Live Lessons when the teacher has approved the session to end. If students leave before they receive approval, they will be marked absent for that day.
- 7. Students will need to log into Google Classroom to complete daily attendance on Non-Attendance days as well. If you fail to log in & complete the assignments you will be marked absent that day.

Distance Learning Expectations

Also, when participating in the virtual classrooms, make sure that you engage in the discussions, ask and answer questions, and fully immerse yourself in the online learning experience. This will serve as very helpful training for your future college courses and even potential careers. Start your online etiquette training now!
- 6. Cyberbullying will not be tolerated! Please refrain from making any negative verbal comments or posting any negative or inappropriate comments towards anyone, including faculty and students.
