### Nutrition Services Complaint / Discrimination Procedure

Any person alleging discrimination based on race, color, national origin, sex, age, or disability has a right to file a complaint within 180 days of the alleged discriminatory action. All civil rights complaints within Mesa County Valley SD 51's Food and Nutrition Services Department should be directed to Dan Sharp, Director – Nutrition Services. Mr. Sharp can be reached via phone at 970-254-5191 or by email at [Dan.Sharp@d51schools.org](mailto:Dan.Sharp@d51schools.org). Complaints can be submitted verbally, in writing, or anonymously.

Mesa County Valley SD 51's Food and Nutrition Services Department will obtain all necessary complaint information and process the complaint within 90 days. The complaint will be forwarded to the Colorado Department of Education, School Nutrition Unit, 1525 Sherman Street, Suit 309 Denver, CO 80203

Complete form and submit to Dan Sharp, Director – Nutrition Services within 180 days of the alleged discriminatory action. Forms can be submitted via email to [Dan.Sharp@d51schools.org](mailto:Dan.Sharp@d51schools.org) or through US mail to Nutrition Services, 2280 East Main St., Grand Junction, CO 81501.

In accordance with federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, this institution is prohibited from discriminating on the basis of race, color, national origin, sex (including gender identity and sexual orientation), disability, age, or reprisal or retaliation for prior civil rights activity.

The letter must contain the complainant's name, address, telephone number, and a written description of the alleged discriminatory action in sufficient detail to inform the Assistant Secretary for Civil Rights (ASCR) about the nature and date of an alleged civil rights violation.
