After School Programs/Clubs

- 1) All students participating in a club need a signed permission slip on file prior to participating in it. Permission slips have been distributed to all homeroom teachers. Return all forms to main Jimmy Deschaine.
- 2) Requests for club participation will be processed on a first come first served basis.
- 3) Students are required to complete the **"After School/Late Bus Google Form"** by 12:00 pm for each day they intend on staying after school.
- 4) All club participation is capped at 16 students per day/club.
- 5) Students must work on an academic task/HW for the first 15 minutes in order to meet Title 1 requirements.
- 6) Students will be brought to late bus only after they are called by Ms. Minella. Students should be supervised by teachers until all students have exited the building.
- 7) Attendance must be taken prior to student departure.
- 8) All clubs will run from February 3 to May 28, 2020. There are 16 sessions per after school club. Due to vacation days or possible snow days, the end date could be in June.
