# Definitions

AAS- Acronym for academic administrator share. For each year, this is the proportion of academic administration as a fraction in total administration counts.

Academic Administrators – Tier 1: Deans and (Provost/V.P. of Academic Affairs)

Academic Administrators – Tier 2: Associate Deans, Associate Provosts, Vice Provosts, Associate V.P. of Academic Affairs

Academic Administrator – Tier 3: Assistant Deans, Assistant Provosts, Assistant V.P. of Academic Affairs

Administrative payroll per student: gross administrative payroll to all bargaining units in the administrative category, divided by total student enrollment for the year.

COT: acronym for Colleges of Technology

EAS- Acronym for executive administrator share. For each year, this is the proportion of executive administration in total administration counts.

Executive Administrator – Tier 1: Vice Presidents excluding Academic Affairs

Executive Administrator – Tier 2: Associate Vice Presidents excluding Academic Affairs

Executive Administrator – Tier 3: Assistant Vice Presidents excluding Academic Affairs

RUC: acronym for Research University Centers

SPAA- Acronym for students per academic administrator, constructed as total enrollment in year t divided by the sum of academic administrator counts in tiers 1-3 in year t.

SPEA- Acronym for students per executive administrator, constructed as total enrollment in year t divided by the sum of executive administrator counts in tiers 1-3 in year t.

# Introduction

This report address the SUNY Faculty Senate need to understand trends in the composition of administration through time. This report was commissioned through a charge given to the Operations Committee of the Faculty Senate. To support the charge, Operations Committee was given campus-year level data on payroll and administrator counts by SUNY title. The quality of the data prevents most useful inference- there is no information about local titles (which differ from SUNY titles), and no associated demographic information.

With the available data, there are few conclusions that can be drawn. When making a dichotomy of academic administrators versus executive administrators based on SUNY titles, the share of each in total administration counts is largely stable through time for the vast majority of SUNY campuses. Likewise, when stratifying administrators by perceived level of authority based on SUNY title, most campuses (and therefore most campuses) have largely stable administrator counts, with minor fluctuations around the Great Recession and recovery.

On account of the missing local title data and missing demographic information, the only major conclusion with the initial data is that a multiphase study is needed. The second phase of the study will be to conduct analysis with local titles and non-payroll measures of administrative presence detailed below, while the third phase will address demographic composition.


This new multiphase study will include the collection of detailed, campus-year level data from multiple sources. The ideal data will include, but not be limited to, all costs associated with administration per institution (direct administration costs, indirect administration costs, FFE, associated utility costs, HVAC costs, maintenance, office expenses, supplies, travel, payroll costs, support personnel, physical plant costs). In addition to providing a complete sample of data associated with the trends in the composition of administration within SUNY schools, the ideal sample will mitigate issues associated with the current source of data such as the differences found in the operational definition for administration personnel throughout the SUNY system.




Administrator Counts - Albany



Students per administrator - Albany



Students Per Academic Administrator (SPAA) - Research University Centers






### Administrative Payroll per Student- Comprehensive Colleges





# Benchmarking with Outcome Data



The purpose of this section is to make efficiency comparisons between campuses in the same sector. To accomplish this, it is necessary to create a unit of account that is comparable across campuses of different size and location. Once an appropriate unit of account is constructed, a comparison will be made on the levels of outcomes (like retention and graduation rates) per unit of account.


The process currently is as follows:

1. Construct a “unit administrative cost” as administrative payroll divided by enrollment.
2. Divide this unit administrative cost by an outcome like 6 year degree completion rate or retention rate
3. What you are left with is the average administrative expense, per student, per unit of outcome.


With the data transformed in this manner, it may be possible to make an argument based on an “efficient frontier”. The idea, roughly speaking, would be to identify the campuses that have the lowest expenditures per unit outcome. For most sectors, this efficient campus is likely to be time varying. It would then be possible to go a step further and do some qualitative analysis regarding the practices that afforded these campuses their advantage.



Administrative payroll per student per percentage point retention rate - Comprehensive Colleges




Administrative payroll per student per percentage point 6 year graduation rate - Comprehensive Colleges
