Contracts for purchase will be put into effect by means of purchase order executed by the Board of Education after tabulations are compiled, evaluated and approved by the Board.

SPECIFICATIONS

PART I – GENERAL

Installer: Firm with no less than five years of concrete experience, similar to the work of this section. Proof of vendor's license and bonding is required. Failure to comply with these requirements will render this bid null and void.

Manufacturer: Company is required to have not less than five (5) years of production experience with concrete similar to types specified in this section; and whose published product literature clearly indicates compliance of products with the requirements of this section.

Warranty: One year warranty to cover materials and workmanship.

PART II – CONCRETE REPLACEMENT AND REPAIR

- This project area includes numerous locations in the Dothan City School District.
- This contract is intended to be ongoing and upon satisfaction by both parties, continue for a total period of up to two years. Work will be requested by the Owner to the Contractor by Work Order.
- The work generally includes: the replacement of concrete curb, sidewalk, flatwork, driveways, masonry wall repair, and curb ramps as required by Work Order prepared and presented to the contractor by the Owner.
- Contractor is responsible for the concrete until completely dry.
- Contractor is responsible to perform work in accordance with all OSHA standards.
- Contractor is responsible to repair any grass or ground area destroyed during their completion of this project.
- Pricing is needed for the following items:

Price for concrete sidewalk and flatwork replacement per square yard.

Price for standard curb replacement per linear foot.

Price for concrete gutter curb replacement.

Price for concrete driveway replacement.

Price for Masonry and wall repair.
