# COVID-19 Testing Program- Students

- 1100+ students are tested each week
  - Testing is done during school hours
  - PCR testing is administered by SHOTs
  - Results are available between 24-36 hours of test collection
  - Parents can opt-in and out of testing at anytime
- Results are sent electronically to parents, District Nurses and HR
  - Any positive results are noted, contact tracing begins, and quarantining procedures are implemented

# COVID-19 Testing Program- Staff

- Approximately 509 staff are mandatorily being tested each week in accordance with State Guidelines
  - Testing is done in AM and PM on Tuesdays at each site with make-up day on Wed
  - PCR testing is administered by SHOTs
  - Results are available between 24-36 hours of test collection
  - Staff who are vaccinated and have submitted their vaccination cards to HR are not required to test
  - Employees also have the option to go to any preferred medical provider for alternative times or other clinical test options (Per LADPH, home tests are not allowed at this time)
- Results are sent electronically to HR
  - Any positive results are noted, contact tracing begins, and quarantining procedures are implemented

# Additional Site Support

- District office staff supports school sites every Wednesday for student Covid-19 testing
- Medical Assistants from our own CTE Pathway support each site on Tuesdays for staff testing
  - Medical Assistants received specialized training before assisting sites
  - CTE coursework credit is given for the work being performed

# Additional Site Support – PubSEG & COVID Clinic

- Partnerships with PubSEG & COVID Clinic to support our COVID prevention efforts
  - PUBSEG will provide 3 full time staff who will work 7 days a week preforming contact tracing needs.
  - COVID Clinic will provide more Covid testing opportunities for any staff wishing to be tested weekly





### **District Outreach**

- COVID-19 Vaccination Program
  - March 2021 the District worked at length to engage partners including Compton Community College, Local Clinics, and Whittier Hospital for the just released vaccines for District employees
  - After extensive outreach to all employees, 768 staff redeemed vaccination codes and received at least their first dose.
  - Between the District's efforts and our employees' initiative we have approximately 1,558 employees vaccinated.

## District Outreach (cont'd)

- PUSD's COVID-19 Vaccination Clinic
  - June 2021 A partnership between PUSD, LA County Health, and Paramount Pharmacy was developed to deliver vaccinations to staff, students and the Paramount Community
  - The Clinic is located at Jefferson School inside their MPR and is open most Fridays from 4-8pm
  - The Clinic is supported by PUSD staff, Paramount Pharmacist, nursing students, and volunteers
  - 1,589 people have been vaccinated so far

## Quarantine Guidelines

#### **QUARANTINE GUIDELINE\***

The following will happen when someone is in close contact (with in six feet) with a positive individual for 15 minutes or more (within a 24-hour period.) Follow the column based on the COVID exposed individual's vaccination status. Fully vaccinated means 14 days after final vaccination.

Fully Vaccinated	Unvaccinated
Not required to quarantine.	Required to quarantine (stay home) for 10 days.
Must monitor self for symptoms for 14- days.	• Exposed individual tests with a laboratory confirmed test on day 6 of exposure and they wait 48 hours for results and if negative, the individual may return to the site on Day 8 if they remain asymptomatic.
If symptoms develop during that time, the individual needs to stay home:  Employees notify supervisor  Parents notify school for students A quarantine will be required.  *Based on surrent guidelines from the Los Angelo	• Symptoms develop during the 10-day quarantine, an adjusted quarantine timeline will be developed.

## **COVID Compliance Team**

- The team was reconvened to update the District COVID plan.
- Areas of the plan were updated to follow current CDPH/LADPH guidelines
- The compliance team reviewed the documents that were presented at the beginning of the year and updated them to assure consistency of practices
- Magnets were distributed to all families to serve as a reminder of keeping students' home if they are experiencing COVID-like symptoms
- The value of vaccines was included into the plan
- A statement was added to the plan that acknowledges that the "document serves as a basis, site variations may exist related to staffing, facilities and related needs".

# **HVAC Systems**

- Sites have HEPA air filters placed inside all rooms and offices in addition to the regular HVAC systems
- All sites in the district have MERV-13 or MERV-16 filtration on their HVAC systems
  - Beginning this month sites that currently utilize MERV-13 and being upgraded to MERV-16



# Personal Protective Equipment (PPE)

- All classrooms and offices have PPE provided for staff and students
- Site supplies are regularly refreshed, and new equipment can be requested by any site with same day deliver in most cases
- Specialized PPE for programs such as Speech, Mod/Severe SDC, and for COVID testing is supplied as needed




