- Call to order: Lunch served 11:45 A.M. Meeting called to order by Janna Berry 12:02 p.m.

- Minutes: Members reviewed minutes from September 18, 2019 meeting. Kersey motioned to accept and Dyan Heard seconded motion. Minutes stand as reviewed.
- Old Business: Nichols and Berry updated the SNPACC committee on new legislation concerning Stop The Bleed initiative. Nichols still waiting on kits for skills to be taught in Berry's Health and Coffman's PE classes. School nurses have completed all Hearing and Vision screenings for grades K-8, (except 7th grade). Those students will be completed after break. 403 flu vaccines were administered during the school's Oct 13th Flu Clinic. 12 staff members took advantage of the CardiOptics Ultrasounds service provided on November 15th. Mrs. Cheadle and Mr Jason Belcher updated the committee on how the extra 40 minutes of recess has been implemented in K-6. Mr. Jason Belcher updated the committee that new water fountains were installed in the Middle School replacing the old porcelain ones. He thanked the custodians for the installation. Nichols informed the committee of the \$1000 ISEP grant that was awarded that was used to construct a new four-square pad for the Middle School students to use during the new recess minutes.
- New Business: K Jones discussed the second quarter menus. Berry discussed the ADE Commissioner Memos (20-023 and 20-022) which outlines the Wellness/SNPAAC committee responsibilities and for the completion of the Triennial Assessment in 2020. Berry will complete the assessment and the committee will review during 4th quarter meeting. The Triennial Assessment is to update the school's Wellness Policy. St Bernard's Mobile Mammogram will be on campus February 4th. L Romine has updated the school's website with the new committee members.
