AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in terms and courses of study, providing for economics and personal finance course graduation requirement and further providing for economic education and personal financial literacy programs; and 8 abrogating regulations. The General Assembly of the Commonwealth of Pennsylvania 10 11 hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 12 13 as the Public School Code of 1949, is amended by adding a 14 section to read: 15 Section 1529. Economics and Personal Finance Course Graduation Requirement. -- (a) Notwithstanding any other 16 17 provision of law, there shall be a high school graduation 18 requirement for students to complete an individual economics and 19 personal finance course in addition to the high school 20 graduation requirements provided under SECTION 121 AND 22 Pa.
- 21 Code § 4.24 (relating to high school graduation requirements).

- 1 (b) A student who completes the economics and personal
- 2 <u>finance course under subsection (a) may apply the successful</u>
- 3 completion of the course to satisfy the student's social
- 4 <u>studies</u>, <u>family and consumer science or mathematics or business</u>
- 5 <u>education credit requirement for graduation. The governing body</u>
- 6 of the student's high school may determine the graduation credit
- 7 requirement to which the credit earned by the student is
- 8 applied.
- 9 <u>(c) To carry out the provisions of this section, school</u> <--
- 10 entities shall train existing teachers in the school entity to
- 11 teach the economics and personal finance course under subsection
- 12 (a).
- 13 (d) (C) Teachers of economics, economic education and <--
- 14 personal financial literacy shall include the following
- 15 <u>curriculum when teaching the economics and personal finance</u>
- 16 course under subsection (a):
- 17 (1) The true cost of credit.
- 18 (2) Choosing and managing a credit card, including, but not
- 19 limited to, the calculation of the annual percentage rate and
- 20 compounding interest.
- 21 (3) Borrowing money for an automobile or other large
- 22 purchase.
- 23 (4) Home mortgages.
- 24 (5) Credit scoring and credit reports.
- 25 (6) Planning and paying for postsecondary education.
- 26 (7) Basic principles of personal insurance policies.
- 27 (8) Basic principles of how to prepare and file Federal,
- 28 State and local tax returns.
- 29 <u>(e) The department shall require that teachers of economics, <--</u>
- 30 economic education and personal financial literacy attain the

- 2 <u>department deems necessary to ensure that the intent and</u>
- 3 provisions of this section are carried out. (D) The department <--
- 4 <u>shall require a school entity to make available a course in</u>
- 5 <u>related professional development for teachers and potential</u>
- 6 teachers of economics, economic education and personal financial
- 7 <u>literacy</u> TO ENSURE THAT THE INTENT AND PROVISIONS OF THIS_ <--
- 8 SECTION ARE CARRIED OUT.
- 9 (f) (E) As used in this section, the following words and <--
- 10 phrases shall have the meanings given to them in this subsection
- 11 unless the context clearly indicates otherwise:
- 12 "Department" means the Department of Education of the
- 13 <u>Commonwealth.</u>
- "School entity" means a local education provider that <--
- 15 <u>includes all public school districts</u>, charter schools, public
- 16 charter schools, public regional charter schools, cyber charter
- 17 schools, public cyber charter schools, approved private schools
- 18 or intermediate units. SCHOOL DISTRICT, CHARTER SCHOOL, CYBER <--
- 19 CHARTER SCHOOL OR REGIONAL CHARTER SCHOOL.
- 20 Section 2. Section 1551(a) of the act is amended to read:
- 21 Section 1551. Economic Education and Personal Financial
- 22 Literacy Programs. -- (a) The department shall have the power and
- 23 its duty shall be to:
- 24 (1) Provide resource information on economics, economic
- 25 education and personal financial literacy to educators and
- 26 public and private schools and organizations.
- 27 (2) Provide for the distribution, including through the
- 28 department's Internet website, to school entities or private,
- 29 nonpublic, elementary or secondary schools in this Commonwealth,
- 30 teacher curriculum materials and other available resources,

- 1 including <u>materials</u> or other resources necessary to teach the
- 2 curriculum specified under section 1529(d) 1529(C) and materials <--
- 3 or other resources for economic education partnership programs,
- 4 on economic education and personal financial literacy, including
- 5 the basic principle involved with earning, spending, saving and
- 6 investing money. The materials shall align with and complement
- 7 existing State standards for Economics, Family and Consumer
- 8 Science, and Career Education and Work as set forth in 22 Pa.
- 9 Code Ch. 4 (relating to academic standards and assessment).
- 10 (3) Identify and recognize Commonwealth schools that
- 11 implement exemplary economic and economic education and personal
- 12 financial literacy curricula at each benchmark as set forth in
- 13 existing State standards for Economics, Family and Consumer
- 14 Science, and Career Education and Work as set forth in 22 Pa.
- 15 Code Ch. 4.
- 16 (4) Maintain an inventory of economic education and personal
- 17 financial literacy materials, programs and resources available
- 18 in Commonwealth agencies.

- 20 Section 3. The provisions of 22 Pa. Code are abrogated
- 21 insofar as they are inconsistent with this act.
- 22 Section 4. This act shall take effect July 1, 2023.
