- motivated by an actual or a perceived personal characteristic including race, national origin, martial status, sexual orientation, gender identify, religion, ancestry, physical attributes, socioeconomic status, familial status, or physical or mental abilities, disability; or,
- · threatening or seriously intimidating; and,
- occurs on school property, at a school activity or event, or on a school bus; or,
- substantially disrupts the orderly operation of a school.
   "Electronic communication" means a communication transmitted by means of an electronic device including a telephone, cellular phone, computer, or
