# B. Learning Continuity and Attendance Plan

Parents made the following recommendations, suggestions, input, and/or comments:

## Distance Learning

- "Happy that students will be connecting with their teacher daily..."
- "I have multiple children and work, I am concerned about how they will learn..."
- "I have a child on an IEP, how will they get their service?...my child wasn't given enough support..."
- "I have a young child, I am worried it will be complicated for her on the computer..."
- "How will the District or school keep my child focused while on the computer?..."
- "How will the District ensure teachers are connecting and teaching daily?..."
- "Can the District create something so I know what my child will be learning?..."
- "I am concerned, I have four children...all grades...I don't know how it will go for them..."
- "I am not aware of what the school day will look like..."
- "I would like training to assist my child..."
- "I am not aware of guidelines..."
- "There is no Spanish speaking staff at Dutcher, can there be a staff that is able to communicate with Spanish speaking parents?..."
- "I believe the packets at Round Up should have information for parents...how will roll call be taken?..."
- "I don't know how Distance Learning will work..."
- "I need instructions on what to do if my child isn't able to log on..."

#### **Devices & Connectivity**

- "Concerned about my internet being slow and my child not getting the information..."
- "I am concerned my internet is slow..."
- "I have internet access..."
- "I don't know if I can afford to pay for my internet, can the District help with that?..."

- "I have no concerns or suggestions..."
- "I have slow internet, I don't want my child to lose connection..."
- "Parents may need help with the internet..."

## Social-Emotional Well-Being

- "Can the district or school offer times for my child to socialize with other children..."
- "I like the District or school to have opportunities for my child to connect to other activities..."
- "Can the District help if my child is moody or bored while on the computer?..."
- "Will the District have helpful tips for parents on behavior and motivation?..."
- "Is the teacher able to do small groups?..."
- "Will lunch be served at all school sites?...I have no transportation..."
- "I want the schools to have clubs on the computer...reading clubs, teams...play games on the computer..."
- "I want my child to be able to connect with his teacher on the computer..."
- "Can someone at the school do small groups to check in with students?..."
- "I believe students need to socialize with friends..."

## Meals

- "Can the meals continue how they were when the District was in school closure?..."
- "Can the EBT cards continue?..."
- "I would like the meals to be served at all schools..."
- "I'd like the District to continue meals the same that as was during the school closure..."
- "I am not able to pick up meals because I am at work, can a neighbor or friend pick them up for me?..."
- "Will the EBT cards continue?..."
- "How will lunch be provided?...I believe it would be best to receive the EBT cards to buy groceries for students' meals...not all parents have vehicles to pick up meals..."

#### Pupil Engagement & Outreach

- "I'd like the District to offer training to parents about the programs my child will use..."
- "I'd like the District to offer tips for parents on how to help their child on the computer..."
- "If my child has a question, how do they ask?..."
- "It's important for parents to have a routine for their students...can the District help with communicating this to parents?..."
- "Older student need reminders to be ready and have their chrome books charged..."
