*To advance to the next tier, a county must also meet health equity measures as described on the right.

**Case rate will be determined using confirmed (PCR-only) cases, and will not include state and federal inmate cases. Case rates include an adjustment factor for counties that are testing above the state average. The incidence is adjusted downwards in a graduated fashion, with a maximum adjustment at twice the State average testing rate.

***HCA is tracking and conducting contact tracing on antigen+ cases

Updates as of 12/08/2020:

- CDPH continues to implement and operate the Blueprint For a Safer Economy under the emergency brakes action announced on November 9, 2020. Counties who are not currently under a regional Stay at Home Order may be moved to a more restrictive tier based on Blueprint data assessed each week. Once announced, the county is required to implement tier related restrictions by 11:59pm the next day.
- Thereafter, if a county enters into a regional Stay at Home Order based on ICU capacity, the restrictions associated with that order would take effect.
- In light of the recent, unprecedented surge in rate of increase of cases, notwithstanding the Blueprint framework outlined below, the following changes have been effective since 11/9/2020 and will stay in place until further notice:
 - Tier assignments may occur any day of the week and may occur more than once a week when CDPH determines that the most recent reliable data indicate that immediate action is needed to address COVID-19 transmission in a county.
 - Counties may be moved back more than one tier if CDPH determines that the data support the more intensive intervention. Key considerations will include the rate of increase in new cases and/or test positivity, more recent data as noted below, public health capacity, and other epidemiological factors.
 - The most recent reliable data will be used to complete the assessment.

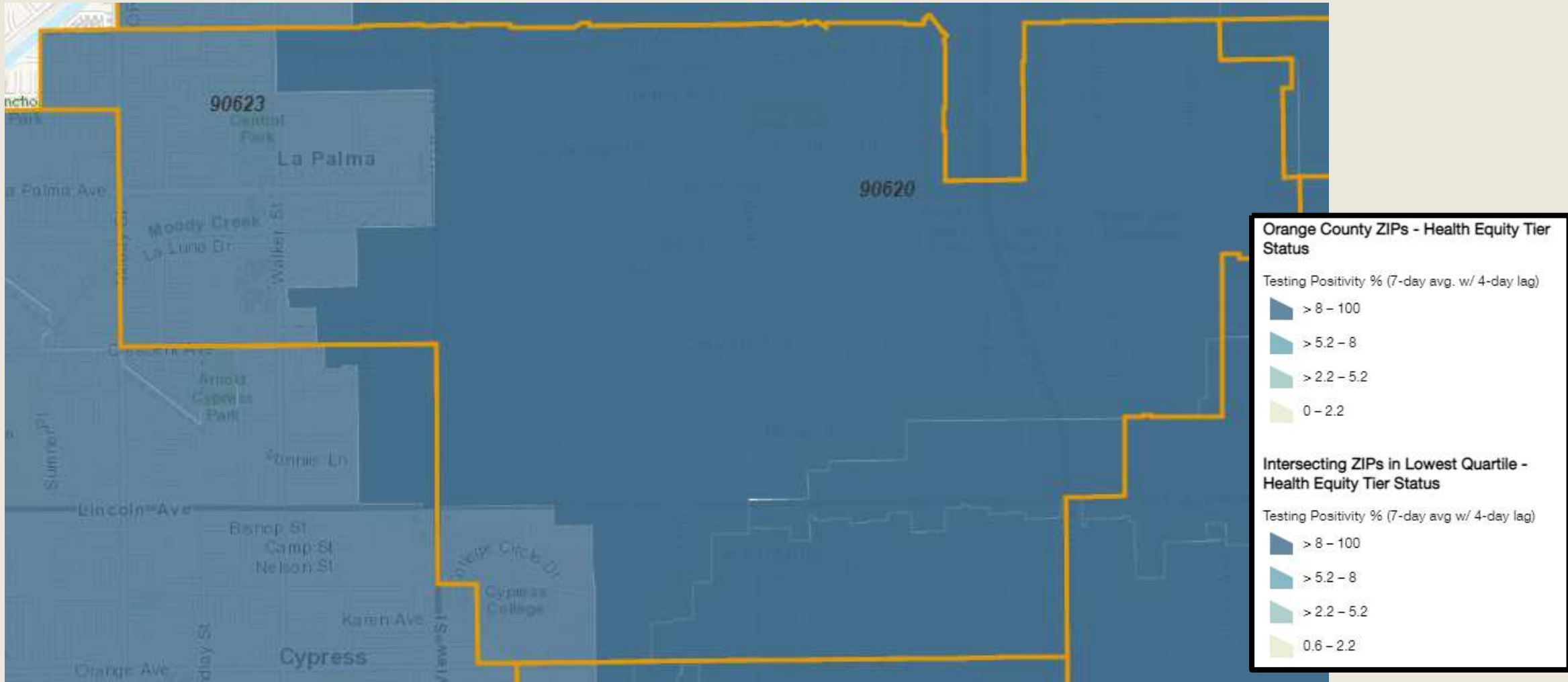
Moving through the Tiers

Rules of the framework:

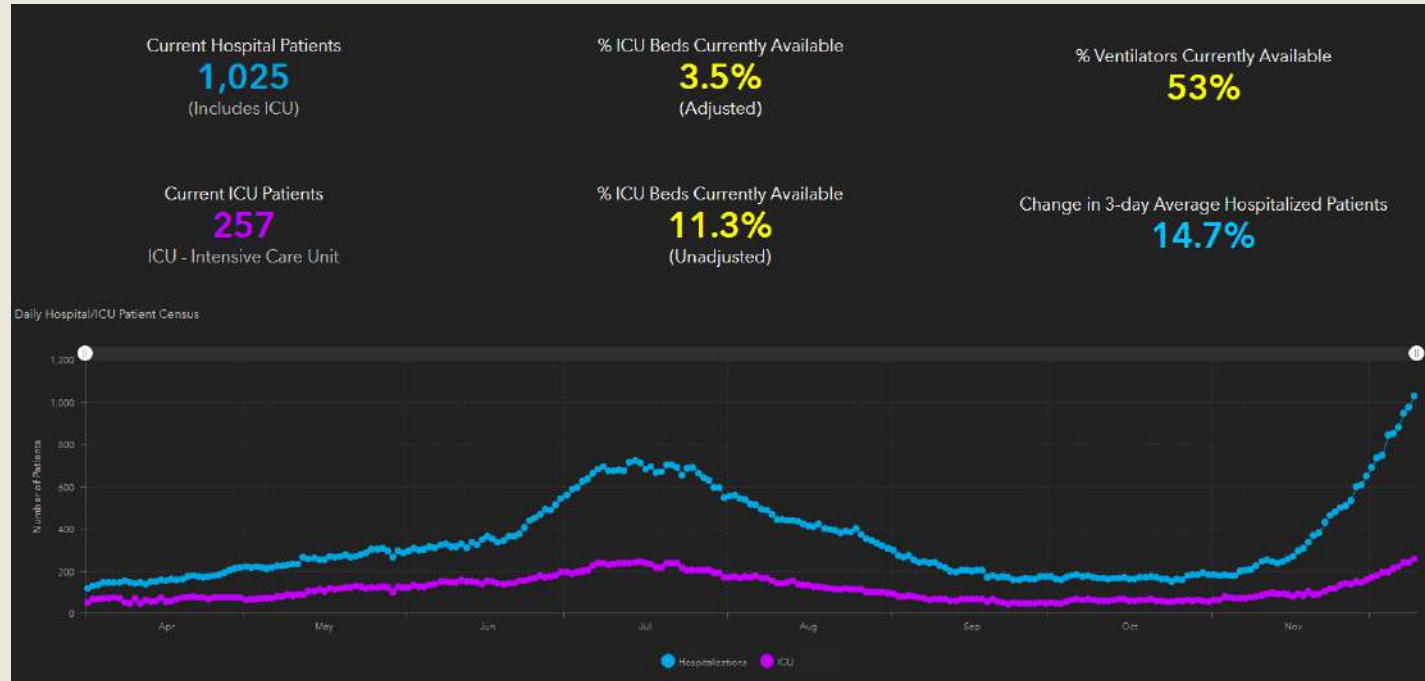
1. CDPH will assess indicators weekly on Mondays and release updated tier assignments on Tuesdays.
2. A county must remain in a tier for a minimum of three weeks before being able to advance to a less restrictive tier.

TIER DATA

- Informs at the county level
- Provides specific guidance to various industries through Governor's Blueprint for a Safer Reopening
- Prevents districts that have not yet opened from reopening unless the county is out of Tier I (purple)



NEW - GOVERNOR'S STAY AT HOME ORDER



This is a Regional data point.

COVID-19 stay-at-home regions

California's new stay-at-home orders are broken down by five regions based on ICU capacity within regional hospital networks. No region is under the order yet, but would be locked down if its ICU availability falls below 15%.

Sectors Open: State's Regional Stay-at-Home Order

And lastly, the following sectors are allowed to remain open in the Southern California Region with the state's Regional Stay-at-Home when a remote option is not possible with appropriate infectious disease preventative measures including 100 percent masking and physical distancing:

- Critical infrastructure
- Schools – K-12
- Non-urgent medical and dental care
- Childcare and pre-K

COVID-19: State's Regional Stay-at-Home Order

On December 3, Governor Gavin Newsom announced the state's [Regional Stay-at-Home Order](#).

Orange County was placed in the Southern California Region which includes the following counties: Imperial, Inyo, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, Ventura.

Should the Southern California Region drop below the 15 percent Intensive Care Unit (ICU) capacity, the state's Regional Stay-at-Home Order would go into effect. Orange County would have **24 hours** in which to comply with the state's Regional Stay-at-Home Order.

Sector Closures: State's Regional Stay-at-Home Order

Should the state's Regional Stay-at-Home Order go into effect, all Southern California Region counties including Orange County must close the following sectors within 24 hours:

- Indoor and outdoor playgrounds
- Indoor recreational facilities
- Hair salons and barbershops
- Personal care services
- Museums, zoos, and aquariums
- Movie theaters
- Wineries
- Bars, breweries, and distilleries
- Family entertainment centers
- Cardrooms and satellite wagering
- Limited sports
- Live audience sports
- Amusement parks

Sector Modifications: State's Regional Stay-at-Home Order

In addition to the closures, the following sectors in the Southern California Region will have additional modifications in addition to 100 percent masking and physical distancing requirements should the state's Regional Stay-at-Home order go into effect:

- **Outdoor recreational facilities:** Allow outdoor operation only without any food, drink or alcohol sales. Additionally, overnight stays at campgrounds will not be permitted.
- **Retail:** Allow indoor operation at 20 percent capacity with entrance metering and no eating or drinking in the stores. Additionally, special hours should be instituted for seniors and others with chronic conditions or compromised immune systems.

- **Shopping centers:** Allow indoor operation at 20 percent capacity with entrance metering and no eating or drinking in the stores. Additionally, special hours should be instituted for seniors and others with chronic conditions or compromised immune systems.
- **Hotels and lodging:** Allow to open for critical infrastructure support only.
- **Restaurants:** Allow only for take-out, pick-up, or delivery.
- **Offices:** Allow remote only except for critical infrastructure sectors. Working in person is not possible.
- **Places of worship and political expression:** Allow to remain open for religious services and political expression without live audiences. Additionally, testing protocol and "bubbles" are encouraged.
- **Entertainment production including professional sports:** Allow to remain open for entertainment production without live audiences. Additionally, testing protocol and "bubbles" are encouraged.

Sectors Open: State's Regional Stay-at-Home Order

And lastly, the following sectors are allowed to remain open in the Southern California Region with the state's Regional Stay-at-Home when a remote option is not possible with appropriate infectious disease preventative measures including 100 percent masking and physical distancing:

- Critical infrastructure
- Schools – K-12
- Non-urgent medical and dental care
- Childcare and pre-K

Timeline: State's Regional Stay-at-Home Order

Should the Southern California Region go into the Regional Stay-at-Home Order status, it will remain in that status for at least three weeks. The Southern California Region may come out of the Stay-at-Home Order after three weeks, if at that time, hospital ICU capacity projected four weeks out reaches 15 percent. Then individual counties such as Orange County will return to our [Blueprint for a Safer Economy](#) tier determined by their case rate and test positivity. If the ICU capacity for the Southern California Region is less than 15 percent after the three-week period, the ICU capacity will be assessed weekly to determine when the order may be lifted.

What Orange County Residents and Businesses Can Do

There are several steps Orange County residents can do at this time:

- **Get Tested for COVID-19**
The OC Health Care Agency officials are urging residents, especially those with any symptoms, to get tested for the virus.

[COVID-19 testing](#) is now widely available across the county for those who are symptomatic or asymptomatic, with or without insurance, at no cost. Testing takes only a few minutes and results generally come back within two to three days.

If you test positive for COVID-19, stay home and let close contacts know. A close contact is someone you were within 6 feet for at least 15 minutes within a 24-hour period during the infectious period.

- **Stay Home if You Don't Feel Well**
Consult with a health care provider. If you do not have a health care provider, please call the OC Health Care Agency's Health Referral Line at 1(800) 564-8448.
- **Stay Home When Possible**
When you leave the house, avoid crowds and stay 6 feet apart from people not in your household.
- **Do Not Gather**
Do not mix households at this time.
- **Wear a Face Covering**
Wear a face covering you are around people not in your household, especially when indoors.
- **Wash Your Hands Often**
Wash your hands often with soap and water for at least 20 seconds.
- **Avoid Touching Your Eyes, Nose and Mouth with Unwashed Hands**
- **Clean and Disinfect Frequently Touched Surfaces**
- **Understand and Comply with the State's Guideline for Your Business and Events**

- OC Health Care Agency (HCA) will receive 25,350 doses of Pfizer-manufactured COVID-19 vaccine on December 15, 2020.
 - *HCA will distribute this initial supply to Orange County (OC) hospitals for prioritization of their high-risk health care workers as part of Phase 1a of a multi-phased [plan](#) developed through the CDPH Community Vaccine Advisory Committee.*

You will be referred to COVID-19 resources so you can quickly get the testing and care you need to prevent exposing others in your community.
