Superintendent Barile updated the Board on the administrative changes at HHES upon Mrs. Dymond's leave. Mrs. Scheithe will take Mrs. Dymond's place temporarily and Mrs. Farias

will fill the Assistant Principal's position. Mr. Barile updated the Board on Professional Meeting Time after school for teachers.

SUBCOMMITTEE REPORTS

Communications- 1/3/17- Tara Lerner said the subcommittee discussed PDF/Links on the website and SchoolMessenger as well as a discussion on a live streaming vendor.

Policy- 1/4/17 - Steve Harding said the subcommittee continued discussion on the #9000 series and talked about ECS funding. Director of Special Services spoke about upcoming policy changes to Seclusion & Restraint, increase hours of instruction for expelled students and "Burden of Proof".

B & FC- 1/9/17 – Paul Checco said the subcommittee received an update on the BHS water project, Honeywell, BHS roof RFP, School Dude, CIP 10 year plan, Architect RFP, CES floor, and the A/C in the BHS Science wing. ROBOTICS TRIP

The Board continued its discussion on the Superintendent’s 2017-2018 budget and approve submission of such to the First Selectman by the end of January. Mr. Barile presented a revised budget power point presentation from his original budget presentation that the Board received on December 21, 2016. This revised presentation highlighted the two “comeback items” being put back into the budget, the K-2 World Language position and the BHS Writing Lab position. Mr. Renda and Mrs. Spencer presented a power point and had discussion on the 5th grade module.

After discussion, the Board decided to schedule a Special Meeting to be held on Tuesday, January 24, 2017 to further discuss the budget.
