# JOB PURPOSE:

Under the general supervision of the Maintenance Superintendent, responsible for the safe and efficient operation of varied heavy highway maintenance equipment and manual labor duties as required to accomplish departmental objectives and tasks. Work of this class is distinguished not only by the nature of equipment operated but also by the variety of equipment used, the nature of special assignments undertaken, initiative required, and the safety precautions and hazards involved.

1.	Safely operates a variety of heavy equipment engaged in highway maintenance, repair and construction activities such as grader, backhoes, tandem axle dump truck, oversize semi, heavy loaders (over 75 hp), tractor mounted mowers, hot asphalt distributors and pavers, or similar equipment. Blades, grades shapes, patches and shoulders roads, plows snow, salt/sand roads, loads gravel, sand, and other materials; lays out blacktop with blade or paver, ditching and building driveways with dozer and skid loader, and general construction activities. Wood and concrete culvert construction and general repair. Operators in the outer shops must also plan their own work schedules; analyze road maintenance needs, under the supervision of the Maintenance Superintendent.	56%	
2.	Performs daily maintenance checks on assigned equipment. Maintains equipment by changing oil, lubricating, replacing brakes, changing tires, changing/sharpening mower blades, wiring, replacing hydraulic components, etc to keep equipment in good working conditions. Performs field maintenance or repairs and some welding.	12%	
3.	Performs a variety of manual tasks related to road maintenance such as crack filling, hot and cold asphalt patching, cutting brush with chainsaws, mastic, and cleaning and thawing culverts. Shoveling, cutting steel	15%

# **MINIMUM QUALIFICATIONS:**

- High school diploma or GED.
- Three years experience operating equipment with one year experience operating heavy equipment.
- Must have a valid (Class A) Minnesota driver's license and be free of any major violations for last three years.
- Will be required to obtain and hold all necessary license and endorsements needed to operate assigned equipment. These may include, but are not limited to, HazMat, Tanker, and Chemical Application.

# KNOWLEDGE/SKILLS/ABILITIES REQUIRED:

- Considerable knowledge in regards to operating and servicing of assigned equipment including adaptations and specialized uses to which equipment can safely be used in meeting emergency or unusual conditions.
- Traffic laws, ordinances, and regulations involved in equipment operation.
- Considerable knowledge of occupational hazards involved and the safety precautions necessary in equipment operation.
- Skills in operating and servicing a variety of medium and heavy road equipment.
- The ability to competently operate heavy road maintenance equipment by utilizing complex skills and abilities acquired from experience or training.
- Answer to 24 hour on-call demand, and perform strenuous work under extreme and varying conditions.

- Ability to follow oral and written instruction.
- Ability to locate and safely dig and work around underground gas, power, communications and other utilities with heavy equipment.
- Ability to recognize operational deficiencies in assigned equipment.

Work is medium to heavy, involving lifting and carrying objects weighing over fifty (50) pounds. Working on rough and uneven terrain, standing and walking for extended periods and distance. Finger and manual dexterity and motor coordination are required for the variety of jobs performed. Work will be dirty and hazardous at times; subject to traffic, extreme heat and cold, slippery walking and driving surfaces, cuts, shock hazard, steam burns, possible injury by power tools and machinery, hazardous materials and subject to noise and vibrations from machinery. Working indoors and outdoors in darkness, sun, rain and snow at various temperatures and weather extremes.

# **SAFETY POLICY:**

It is the responsibility of every employee of Dodge County to know and observe the safety policies and procedures of the County. Each employee is expected to perform tasks in a safe and efficient manner while using appropriate safety equipment, clothing, and devices.

### **MISCELLANEOUS INFORMATION:**

At higher level, work focuses on the operations of variety of heavy and specialized equipment.

"In the highway department with minimum staff each employee is responsible to be knowledgeable to do various tasks".

As a blade operator in an outer shop, you have to plan your own work schedule. Such as what road to do first and what needs extra attention.

Also, you need to know what roads need more material and how to best use the material you have available. You will also have to direct truck drivers as to where to place materials.
