

#### I. Executive Summary

Nevada's Read by Grade 3 Program has played a pivotal role in the advancement of early (kindergarten through third grade) literacy efforts across the state of Nevada over the past five years. This state initiative emerged as Nevada's first *Read by Grade 3 Act* in 2015 with the passage and signing of Senate Bill 391. The original Nevada State's *Read by Grade 3 Act* was enacted under the leadership of Governor Brian Sandoval with near unanimous support by both



houses of the Nevada State Legislature. This Act established a comprehensive system of early reading instruction and intervention aimed at accelerating the reading growth of students reading below grade level in kindergarten through third grade.

Nevada's *Read by Grade 3 Act* emerged as part of a national trend of comprehensive early reading initiatives being adopted by multiple states across the nation. One foundational belief has continually driven the work of this national movement - *the belief that a student's trajectory to any future academic success becomes secure only when that student acquires a solid foundation in early reading – particularly by the end of third grade.* Moreover, this belief goes well beyond speculation, as it has been unequivocally validated by decades of evidence-based research studies. One such study was conducted by the Annie E. Casey Foundation in 2011 titled *Double Jeopardy: How Third-Grade Reading Skills and Poverty Influence High School Graduation.* The Casey researchers concluded that "there are multiple life-long consequences facing some of our country's youngest students when their very introduction to formal schooling becomes jeopardized by difficulties in reading." They determined that "learning to read at grade level by the end of third grade is a gateway to lifelong success."

The Nevada Department of Education (NDE) has galvanized this belief by transforming it into the purpose of this program - *to dramatically improve student achievement by ensuring that all Nevada students become grade-level readers by the end of third grade.* This stated purpose of Read by Grade 3 became strategically integrated into the language of Goal #1 of NDE's 2020 Strategy Implementation Plan (STIP). Goal #1 of NDE's STIP plan directs the agency to:

- improve the quality of early childhood (birth 3<sup>rd</sup> grade) programs
- establish an aligned system of screening and assessment across early childhood programs (K-3)
- improve effective literacy instruction for emergent skills and domains of literacy

Since the beginning of this program five programmatic goals have also directed local implementation efforts of Read by Grade 3. These goals direct local programs (LEAs) to implement Read by Grade 3 with the intention of:

- improving student achievement;
- improving K-3 literacy instruction;
- establishing a statewide K-3 assessment framework;
- developing cultures of literacy; and
- ensuring accessibility for all learners.

By 2019 Nevada's Read by Grade 3 Program had clearly established a robust infrastructure for the implementation of early reading instruction and



intervention across the state. With the support of Governor Steve Sisolak, the 2019 Nevada State Legislature made several revisions to numerous requirements of the original law with the passage of Assembly Bill 289 (AB 289). Governor Sisolak signed this revised version of Nevada's *Read by Grade 3 Act* (AB 289) into law in July of 2019.

While AB 289 modified certain elements of the original Read by Grade 3 law (SB 391), a core set of program requirements remained intact. The continuity of these core elements has ensured a sustainability of intent across both versions of the *Read by Grade 3 Act.* These elements have continually directed local programs to:

- develop a Local Literacy Plan that is aligned to the Nevada State Literacy Plan of 2015;
- designate a site-level Read by Grade 3 Literacy Specialist at every public elementary school to lead the work of literacy;
- establish a parent or guardian notification process for all students who have been identified as reading below grade level;
- develop an individualized intervention plan for all identified students that includes regular progress monitoring of students' reading growth;
- participate in required professional learning opportunities specifically designated for Read by Grade 3 Literacy Specialists and classroom educators; and
- administer State Board-approved Reading Assessments for all K-3 students.

Because regular sessions of the Nevada State Legislature are held biennially during odd-numbered years, Nevada's Read by Grade 3 Program has experienced a unique legislative history. In 2015, the passage of the original Read by Grade 3 Act (SB 391) launched the program. In 2017, minimal changes were made to the program. In 2019, as noted above, the passage of a revised *Read by Grade 3 Act* (AB 289) resulted in multiple changes to the original law. Suddenly in March of 2020 Nevada joined the rest of the world in responding to the many implications brought on by the unprecedented COVID-19 virus. In July of 2020

Governor Steve Sisolak convened a Special Session of the Nevada State Legislature to address major budget shortfalls that the state was facing. The Special Session was held from July  $8^{th}$  through July  $19^{th}$ , 2020. Decisions made by this group of policymakers significantly impacted the work of Nevada's Read by Grade 3 Program.

A chronology of this rich history follows.

# II. The Legislative History of Nevada's Read by Grade 3 Program

# A. The 2015 Legislative Session - "Launching the First Biennium"

Nevada's original *Read by Grade 3 Act* (SB 391) was introduced to the Nevada Senate Committee on



Education by Chair Becky Harris on April 7, 2015. Senator Harris began her testimony with a personal narrative about her own lifelong love of reading. She then shared how critical it had been for her to hand down her passion to her own daughter. She was moved to reflect how differently her daughter's experience had been when she stopped and compared it to many children in poverty who resided within her district. Senator Harris's words were quickly followed by a very supportive testimony for SB 391 offered by the Nevada Superintendent of Public Instruction, Dale Erquiaga. An unprecedented number of Nevada leaders and organizations then provided additional testimony in support of SB 391 during that initial hearing. Ultimately SB 391 was passed with near unanimous votes from both houses of the legislature on May 28, 2015. The following summary of Nevada's historic *Read by Grade 3 Act* (NRS 392.750) offers insight into the specific requirements identified within the original *Read by Grade 3 Act* (SB 391).

An Act relating to education; requiring the board of trustees of each school district and the governing body of each charter school to prepare a plan to improve the literacy of pupils enrolled in certain grades; requiring the principal of each public elementary school to designate a learning strategist to train and assist teachers in providing intensive instruction to pupils who have been identified as deficient in the subject area of reading; requiring certain teachers at public schools to complete professional development concerning the subject area of reading; requiring certain interventions for pupils enrolled in kindergarten or grade 1, 2 or 3 who do not achieve adequate proficiency in reading; prohibiting a public school from promoting a pupil to grade 4 if they pupil does not achieve proficiency in reading; providing for a competitive grants program to assist schools in paying for certain literacy programs; and providing other matters properly relating thereto.

Nevada state legislators launched the first year of Read by Grade 3 (2015-2016) with a funding allocation of \$4,879,489.00. Due to an October hiring date of the first Read by Grade 3 Education Programs Professional, this first year was often referred to as a "pilot year". By late November, the first formal competitive grant process was conducted. Initial Read by Grade 3 grant awards were made to 10 local programs including 8 school districts and 2 charter schools. Local implementation of Read by Grade 3 transpired from January through June of 2016. Due to the lengthy regulatory process required for State Board approval of SB

391 assessments, NDE leadership established a menu of twelve different reading assessments from which local programs could select in order to assess the reading progress of their K-3 students.

Legislators expanded Read by Grade 3 funding during its second year of implementation (2016-2017) by allocating \$22,250,574.00. This year marked the first full year of local implementation of Nevada's Read by Grade 3 Program. A second competitive grant process was conducted. The Read by Grade 3 number of awardees more than doubled increasing from 10 to 23 grant awards during this year. Fifteen Nevada school districts and eight charter programs were awarded grants. Approval was granted once again for the same menu of twelve reading assessments for measuring K-3 students' reading progress. Program staffing was expanded during this second year with the hiring of one additional Read by Grade 3 Programs Professional.

#### B. The 2017 Legislative Session -

#### "Staying the Course with the 2nd Biennium"

On February 8, 2017 Dr. Steve Canavero, Nevada's Superintendent of Public Instruction, introduced Assembly Bill 7 (AB 7). This bill was designed as a "clean-up" bill for the Nevada Department of Education. The intent of this bill was to update the language included in several Education statutes to align to new federal language. Nevada's *Read by Grade 3 Act* (SB 391) was included within the language of this bill. Minor changes in language were recommended (i.e. changing "limited English proficient student" to "English learner" and changing "scientifically-based" to "evidence-based"). AB 7 passed both houses with unanimous votes on May 26, 2017.

With continued support from Nevada's Governor Brian Sandoval and Nevada lawmakers, funding for Nevada's Read by Grade 3 Program was re-authorized through Governor Sandoval's budget bill. During the first year of this biennium Read by Grade 3 was allocated \$20,499,999.99. A third competitive grant process was conducted by NDE that resulted in 20 local programs being awarded Read by Grade 3 grants (15 school districts and 5 charters). Due to a late roll-out of awards, this third year of Read by Grade 3 was implemented over a six-month period from January through June of 2018. This year also marked the first year of adoption by the State Board of Education of the NWEA MAP Growth Reading Assessment as a statewide assessment tool for Read by Grade 3. All LEAs across the state began using the MAP assessment to measure K-3 student growth in reading.

During the second year of this biennium (2018-2019) Read by Grade 3 was allocated \$20,499,999.98. Several different competitive grant processes were conducted. They resulted in 15 school districts and 3 charter schools being awarded Read by Grade 3 grants. Read by Grade 3 was implemented across an entire school year during this year. In addition, the NWEA MAP Growth Reading Assessment continued to be administered to K-3 students across the state.

#### C. The 2019 Legislative Session -

#### "A Transformational Start to the Third Biennium"

On April 9, 2019, Assemblyman Tyrone Thompson introduced Assembly Bill 289 (AB 289) to the Assembly Committee on Education. Mr. Thompson began by describing a work group he had been facilitating for several months aimed at revising Nevada's 2015 *Read by Grade 3 Act*. The product of this work group emerged as AB 289. Assemblyman Thompson opened the testimony with a comprehensive presentation on recommended revisions to the previous law. Additional testimonies followed including a presentation by NDE's Deputy Superintendent Dr. Jonathan Moore. After several months and three reprints of the bill, the law was passed on June 2, 2019 with a vote of 28 Yeas and 11 Nays in the Assembly and 17 Yeas and 3 Nays in the Senate. AB 289, the revised *Read by Grade 3 Act* was passed on June 2, 2019. Governor Steve Sisolak signed the bill on June 14, 2019.

AB 289 resulted in multiple revisions to the original *Read by Grade 3 Act* (SB 391) of 2015. Modifications ranged from minor changes in statutory language to comprehensive alterations of complete sections. A complete listing of these changes is provided in the *Read by Grade 3 AB 289 Guidance Document* (Appendix C).

Three overriding revisions were made to Read by Grade 3 in AB 289. They included multiple expansions of scope, an increase in funding, and a complete removal of the Read by Grade 3 mandatory Grade 3 retention requirements. Under this new law, Read by Grade 3 would now be implemented in every Nevada public elementary school. AB 289 also expanded Nevada's previous targeted grade levels (K-3) to now include every grade in the elementary school. Allocations for Read by Grade 3 increased by \$11 million in funding which totaled \$31.4 million per year (the bulk of which was targeted for the hiring of site-level Literacy Specialists).

AB 289 also changed the method used for funding Read by Grade 3 grant awards. After four years of awards being determined through a competitive grant process, Read by Grade 3 awards would now be determined through a noncompetitive grant process (utilizing a weighted funding formula). AB 289 also removed mandatory RBG3 Grade 3 retention requirements for students reading below grade level at the end of third grade.

2019-2020 marked the first year of statewide implementation of the revised *Nevada Read by Grade 3 Act*. From its very start, it quickly progressed into a year of transformation. In just one year's time, the number of Read by Grade 3 grants increased exponentially from 20 programs to 41 programs. The number of impacted schools increased by 72% from 291 to 406. The scope of site-level instruction and intervention expanded to include all grades in the elementary school. Elementary administrators across the state worked diligently to hire a qualified Read by Grade 3 Literacy Specialist to lead their school's literacy efforts. The program continued to administer NWEA's MAP Growth Reading Assessment to measure student growth in reading.

This exciting year would have counted as the third full year of implementation of Read by Grade 3 if the world had not been completely blindsided by the unprecedented global COVID-19 pandemic in March of 2020. Nevada educators worked feverishly to provide instruction through virtual learning and (if necessary) weekly homework packets. Families scrambled to gather online devices and internet access to ensure a continuance of their child's learning. Governor Steve Sisolak authorized multiple coronavirus shutdown restrictions to curtail the COVID-19 impact. Nevada's primary industries of gaming and tourism came to a virtual stop. Unemployment sky-rocketed at historic levels. Within five months the Governor convened a Special Session of the Nevada State Legislature with one primary goal – to resolve the daunting \$1.2 billion budget deficit that the state was facing.

#### D. The First 2020 Special Session - "Maintaining the Gateway"

Governor Steve Sisolak released the *Nevada COVID-19 Fiscal Report* on July 6, 2020. This official report outlined his recommendations for meeting the incredible shortfall. His recommended reductions for the Department of Education to address the shortfall included \$166 million in General Fund reductions. Recommended reductions included ten specific programs – including Read by Grade 3. Read by Grade 3's \$31 million allocation (primarily for the hiring of local Literacy Specialists) was recommended for reduction. Nevada lawmakers met for twelve days during this historic Special Session. In the end, Read by Grade 3 was officially cut from the state budget as part of Assembly Bill 3 (AB 3). On the last day of the session, key lawmakers added Amendment 4 to the bill. This amendment called out the names of specific programs that would be funded should Nevada receive a second round of COVID-19 Federal Relief funds (still being debated by the U.S. Congress). Nevada's Read by Grade 3 Program is the second program named on this list.

At this point in time NDE's Read by Grade 3 Program (which now employs three Education Programs Professionals) is still in operation. While the funding for the local Literacy Specialists has been eliminated, the requirements of AB 289 remain intact. NDE's Read by Grade 3 Team members work diligently to maintain the integrity and the spirit of this critical

early literacy initiative. They do so with a critical eye for effective literacy instruction through a variety of delivery modalities including in-person, hybrid, and virtual learning. Their work is grounded in the simple belief that "learning to read at grade level by the end of third grade is a gateway to lifelong success."

#### **III. Recommendations for Legislation**

#### Read by Grade 3 Recommendations for Nevada Policymakers

(as required in AB 289, Section 11, Amended Language to Section 15 of Chapter 334, Statutes of Nevada 2015, Number 3, Item g)

NDE recommends that state policymakers consider the following recommendations as they work to ensure that the intent of Nevada's 2019 Read by Grade 3 Act (AB 289) is actualized. (NDE also recognizes that certain modifications may need to be made to these recommendations should state policymakers still be addressing the many social, economic, and educational impacts of the COVID-19 pandemic).

- Continue to advance early elementary literacy efforts across Nevada by supporting the work of Nevada's Read by Grade 3 Program. [This is particularly relevant in consideration of budgetary decisions made during the first 2020 Special Session (AB 3)].
- Become familiar with Nevada's Read by Grade 3 Advisory Council that first convened in March
  of 2020. This dedicated group of thirteen Nevada literacy stakeholders from across the state
  has already purposefully advanced the work of Read by Grade 3. Their voices speak for
  Nevada's early literacy needs.
- Support an expansion of opportunities for Nevada educators to attain a School Reading Specialist endorsement to expand an advanced literacy capacity across Nevada.
- Research the addition of a Data-Analytics Unit within the Nevada Department of Education in order to establish an effective data-based decision-making process for all projects administered by this agency.
- Understand how the acquisition of effective literacy skills is an equity issue and that the role of literacy is to provide all Nevada learners with a critical pathway to lifelong success.
- Advocate for early literacy support across Nevada with a lens of diversity. Communicate with constituents who have faced multiple barriers due to their own experiences with illiteracy.
   Work to remove these barriers.
- Support the NDE work that is required for updating the 2015 Nevada State Literacy Plan.
- Support an expanded role of family engagement within NDE's Read by Grade 3 program.
- Participate in and support NDE's 2020-2021 state-wide campaign to celebrate a love of reading. Volunteer to be a reader in a Nevada elementary school during Nevada Read Week – March 1st through March 5th, 2021. Promote the Nevada Reading Week theme – "Change Your World – Read!"
- Recognize the work of all Nevada educators working day-in and day-out to enhance student learning through literacy.
- Support all efforts aimed at advancing early literacy instruction and intervention across Nevada through distance learning. Promote a mindset that understands how critical reading has become during these unprecedented times. Acknowledge that effective distance learning can only be achieved if it is strategically paired with effective reading instruction.

#### IV. Specific AB 289 (2019) Reporting Requirements

Section 11, Amended language of Section 15 of Chapter 334, Statutes of Nevada 2015, Numbers 3-5:

In AB 289, Section 11, Number 4 identifies five sets of site-level information required for reporting purposes. The information is reference as: **Item a)** Identification of Read by Grade 3 schools that received an allocation of money from the Department of Education; **Item b)** the amount of money received by each school; **Item c)** A description of the programs or services for which the money was used by each school; **Item d)** The number of pupils who participated in a program or received service and **Item e)** The average expenditure per pupil for each program or service. Information gathered for these items **(Items a through e)** can be found in the attached Appendices.

In addition, to site-level statistics required for reporting purposes, sites needed to have an evaluation of the effectiveness of the programs, including without limitation, data regarding the academic and linguistic achievement and proficiency of pupils who participated in Read by Grade 3 services. Currently, data is still being collected and analyzed and will be included in the final report required by AB 289 as **Item f**).

The last reporting requirement includes recommendations for future potential legislative changes. **Item g)** includes recommendations for legislation, including, without limitation, legislation to continue to or expand programs or services that are identified as effective in improving the reading proficiency of pupils in kindergarten through grade 5. This item is provided in *Section III. Recommendations for Legislation (page 10)*.
