Designated and Integrated ELD are in every content area:

- Physical Education: Grade 7, standard 4.5. **Describe** the role of physical activity and nutrition in achieving physical fitness.
- Science: Life Science, MS.LS1.3. Use argument supported by evidence for how the body is a system of interacting subsystems composed of groups of cells.
- Math: Grade 8, Standard 8.F.2. Compare properties of two functions each represented in a different way (algebraically, graphically, numerically in tables, or by verbal descriptions).
- History: Grade 7, Standard 7.11.6 Discuss how the principles in the Magna Carta were embodied in such documents as the English Bill of Rights and the American Declaration of Independence.
- Visual Art: Grade 8, Standard 1.1. Use artistic terms when describing the intent and content of works of art.

Reclassification of English Learners

Reclassification Criteria:

- 1. ELPAC Score. Student must score a Level 4 on the Summative ELPAC
- 2. Basic Skills. Student must score Met Standardsqor Exceeded Standardsqon CAASPP or score On Watchqor higher on STAR Reading
- 3. Teacher Recommendation. Teacher recommendation must be based on evaluation of <u>English language acquisition</u> necessary to be successful in the classroom. This does not include evaluation of motivation, behavior, assignment completion, use of home language, etc.
- 4. Parent recommendation. This includes a meeting with the parent to discuss reclassification

Timeline for reclassification:

- Teachers monitor students through Ellevation twice a year, once in December and once in April/May
- Students take Summative ELPAC from February to May, CAASPP from April to May, STAR Reading anytime
- Student ELPAC and CAASPP scores are reported in summer
- District office uses teacher reclassification monitoring forms from April/May and CAASPP/STAR/ELPAC scores to reclassify eligible students during the summer
- Students are placed appropriately for the following school year
- EL Facilitators monitor students who scored a 4 on the ELPAC for potential reclassification during the year

Please note:

- Students transferring to GUSD may not come with scores right away. Placement is based on educated guesses and may change when data arrives.
- ♦ Teachers fill out reclassification forms BEFORE students scores are reported. Base recommendation on English language acquisition needed to navigate your class.
- Be flexible—EL services are not 'one size fits all'. Students will need different supports during different phases of language acquisition.
- Know who your English Learners and RFEP students are! All teachers are responsible for Integrated ELD, and the monitoring of RFEP students for 4 years after reclassification.
