**7A. PUBLIC HEARING**

President Seibert opened the meeting for visitors to speak on a subject not on the Board Agenda. No one came forward to address the Board.

**7B. STUDENT AND STAFF RECOGNITION**

➤ MCCAP Program Recognition

Jennifer Heck, Counselor at Madera South High School gave a brief introduction about the Madera Center College Advantage Program (MCCAP). She said that MCCAP is a collaboration between Madera Unified School District and the Madera Center. This program gives students early exposure to college, and hopefully will make the transition from High School to College much easier. She stated that the students have a Core class on Monday, Wednesday and Friday. On Tuesday and Thursday, the students have elective classes.

Monica Cuevas, Dean of Students, State Center Community College District, Madera, presented information regarding the Madera Center College Advantage Program (MCCAP). Ms. Cuevas introduced three students who spoke about their experiences with the MCCAP program at the Madera Center.

Evan Whitaker, senior at Madera High School said that last year, his junior year, he was ready to quit school. He signed up for the MCCAP program and he has really

enjoyed his experience at the Madera Center. He would advise any student who is a senior to sign up for the program, good grades or not. When he started the MCCAP program his grades were not good, but he has brought up his grade point average during this semester in the program.

Lisben Ursate, senior at Madera High School said that she did not like High School. She signed up for the MCCAP program and has enjoyed it very much also. The teachers are very nice and helpful. She said that this experience has also helped her prepare for job interviews. She said that she will major in some type of criminal science, such as law enforcement, etc.

Garrett Noblett, senior at Madera High School said that the MCCAP program is a wonderful program. It has helped him become more responsible, and it is good training for the transition from high school to college. Since he has attended classes on a college campus, the whole transition from one to the other is such a natural thing. He said that it has given him a good head start on college.

Clerk/Trustee Westley asked Ms. Cuevas if MCCAP is for all students. Her response was that the program is for any student that is a senior. She said that the students blend very well at the College. When the professors are asked about the high school students, they actually prefer the high school students versus the college students. She said that the high school students are excited about being on campus.

Trustee Adams asked Ms. Cuevas if there is a game plan by the High School Counselors to encourage students or provide information to students so that they know what is being provided. Ms. Cuevas' response was that the administration from the College will be meeting with our Madera High School and Madera South High School Administration as well as Counselors to work together to make this program even better. She said that they may also look at occupational programs at other colleges to see if we can offer even more to the students. She also said that she knows that the students that come to the Madera Center have many activities at the High School, and they do not want the students to miss those activities, so they will be working on that. Trustee Adams asked what the standards are to be accepted in this program. Jennifer Heck, Counselor at Madera High School responded that the student has to be on track to graduate and have a 2.5 GPA. The student is tested at the Madera Center. All credits that are accrued at the college go towards High School Credits, as well as College Credits.

Rochelle Noblett, parent of Garrett Noblett addressed the Board to let them know how wonderful this program is for our students. She said that this program is for all students, not just for AP students. She also said that the Counselors at the high school have not always been supportive of this program, and she would like to see all counselors get on board with the MCCAP program.

Trustee Goodwin asked if the units they receive from this program are used to get into

college. Ms. Heck replied that students receive one year of English credit for one semester of work from Madera Center. Ms. Heck also stated that students that have taken courses at the college through the MCCAP program are applying at a lot of different colleges throughout the United States.

Superintendent Risinger commented that the Board makes it very easy for the students to take the classes. We provide transportation as well as purchase the books, so there is no reason why every eligible student should not be involved in the MCCAP program.

➤ **Madera South High School Activities Presentation**

Andy Beakes, Principal of Madera South High School introduced Julie Zimmerman, Activities Director at MSHS. It has been recognized twice in the very short period of time that Madera South High School has been in existence for their activities program. This program has been awarded the Outstanding Activities Program by California Association of Directors of Student Activities. This is a very high honor that CADA allows each year. MSHS is 1 of 38 schools that was recognized out of 800 eligible schools and 1 in 4 in the central valley that has achieved this award.

Ms. Zimmerman then introduced some of her students that participate in the Leadership class. One student raved about the "Breaking down the Walls" assembly that took place not too long ago. It helped students learn about not being biased towards others. It also taught them how to get along better with others. This was just one of the examples of what Ms. Zimmerman provides in the way of activities for MSHS.

President Seibert presented a plaque to Anthony Hayden Miller who achieved the rank of Eagle Scout. Superintendent Risinger read a letter that was sent to Anthony on behalf of himself and Madera Unified School District. The letter praised Anthony for the installation of the Stallion topiary in front of Madera South High School as well as many other projects he has completed in order to achieve the rank of Eagle Scout.
