IC Updates Summary

Release 2303

The Campus Parent and Campus Student apps have been updated with a new home page. This page replaces the Today screen and collets summary information like food service balance, documents that need attention, assignments and grades.

The Person Summary Report has been updated to properly display comments and not overlap other fields.

Household and Transcript data validation rules have been converted to data validation rules for use with the Data Validation piece of Campus Analytics.

A new set of reports and module has been created named Insights. This module will hold reports on information around assessment, attendance, classroom performance and stability for students. This is part of the Campus Analytics. The new reports use the Pivot Designer tools and are able to be exported to various other formats.

A display issue with documents (SPED, RTI, PLP and Literacy) not showing the last modified by information has been fixed.

An enhanced scheduling tool has been created for the Messenger 2.0. This will allow for better scheduling and viewing of messages in the New Look.

Searching with the Filter Designer has been updated to work with the New Look.

Using the Advanced Search option under Course Section in the New Look has been updated to correctly return information.

A new app has been created named Mobile Payments. This allows districts that use the School Store to use a card reader and mobile device to take payments. See the video below for a quick overview:

On the POS 2.0 terminals, a new virtual key pad has been added to allow users to change the quantity of an item in the transaction list.

The Student Gap Scheduler tool was updated to work correctly in the New Look.

A new Staff Planner tool has been created to work outside of the Schedule Wizard. This tool can be used to set up staff information in a school for scheduling courses/sections. The original Staff Planner will still be available through the Schedule Wizard and both can be used at the same time.

The Section Roster Batch report has been updated to include information on IEP and PLP flags for students.

The birthdate field has been corrected to display when searching for All People in the New Look.

Updates have been made to the Academic Programs to accurately update a student status and on-track logic for students in an academic program or with a CTE Certificate.

In the Gradebook, when marking an assignment as Missing by typing an M, the warning message will now display about how the system will score Missing assignments.

An update was made to the Identities tab to correctly identify a new Identity if the start dates are the same.

The Custom Module Setup tool can be used to create custom contact logs and custom forms.

A new contact log has been created for Attendance where attendance letters will now be saved.

A new contact log has also been created for Census that can be used for any person in the system.

The document upload option has been expanded to include the health-related tools of Conditions, Daily Health Log, Health Office Visits, Immunizations, Medications an Screenings.

A new preference has been created to require an Expires Date on Vaccine Exemptions. This will force a user to enter an expiration date for any vaccines that have an exemption.

The Recipient Log has been added to the New Look under Communication.

A new preference has been added to POS 2.0 for an allergy slide out that can automatically open when the terminal is in continuous serve.

A captcha has been added to the create account option in the Public Store to increase security for users.

Searching updates have been made to the New Look that include being able to find phone numbers and search students by student number.

Printing IEP team meeting attendees has been fixed to correctly print in the document.

Staff Assignment Status Codes have been updated to match the CDE Staff Assignment for state reporting.

Updates were made to the Portal Usage Report to correctly report parents who have used the Campus Parent Portal.

The Advisory tool has been updated to correctly sort students with multiple last names or a hyphenated last name.

The Blank Spreadsheet report has been updated to include the period, term and schedule structure in the header.

The Gradebook Export now correctly handles assignments that have commas in the name.

Campus Learning has been updated to include an option for a teacher to be able to submit an assignment on the behalf of a student.

Updates for the Campus Parent and Campus Student apps are available.

The approval/denial letter for FRAM has been updated to show accurate data even if the household has no active address.

When an amendment of a Special Ed Plan is created, the PDF copy of the plan is now an exact copy of the original plan. This error was only caused when generating plans in the New Look.

The New Look Staff Search was updated to better indicate an inactive staff member.

The New Look Student Search was updated to correctly display the current grade of a student that has an enrollment record in the next year. The Student Search was also updated to allow for searching the student number.

Enhancements have been made to the Campus Mobile Payments app to allow for better processing, messaging and look.

POS 2.0 has been updated to include searching by PIN and homeroom teacher. For the homeroom searches, the student roster and HR list information will update either overnight after first use or though running the data update process.

User account security settings have been updated to clarify the process under the two factor authentication and new device notification areas.
