Past President, Susan Butler remarked that the renovation at Murrieta

Valley High School looks great and thanked everyone for their hard work.

Murrieta Teachers Association President, Kathy Ericson shared that as the new MTA President the beginning of school was a very different experience for her this year. Instead of preparing her classroom she was

able to visit schools and students, which she enjoyed very much.

Superintendent Communications

Superintendent Scheer remarked that today was a great first day of school. At Murrieta Mesa High School he witnessed, along the students and faculty, principal Mary Walters dressed as Wonder Woman landing in a helicopter at school. He realized it was going to be a very exciting year when he realized that this crowd included the first graduating class of MMHS. Dr. Scheer praised the Facilities & Operations staff for completing \$1.2 million worth of work in two months. He indicated that the district is working hard to ensure all three high schools are maintained in relation to each other. He also reported that the District is very pleased with the results of Academic Performance Index (API) scores, which is due to the coordination of activities and teachers, strategies and time. He said that it proves a point: create expectations and you see results.

Board Communications

Trustee Robin Crist welcomed everyone back. She shared that she realizes the work that goes into a successful first day of school started six months ago, and what parents see the first date of school is because staff make it look effortless. Referring to the budget, Mrs. Crist stated that there will be tough decisions the in the future, however, our common thread will continue to be what is best for students and making decisions in a collaborative manner that is as painless as possible for employees.

Trustee Kris Thomasian remarked that Murrieta Valley High School looks great and it is important to note that the district put a lot of people to work in this area and because of the economy we were able to do better with less construction costs. Mrs. Thomasian shared that recently she was contacted by a parent who indicated that she had not been notified or able to obtain transportation information regarding her child with special needs. Following her discussion with the parent, she learned that our District not only works with parents on their individual transportation schedule, the assigned bus driver meets with the parents and student a day or so prior so everyone is on the same page. Mrs. Thomasian remarked that this is outstanding service to our families.

Trustee Ken Dickson agreed with Dr. Scheer that it was a good day at the schools. He commented on the technology available and indicated that the common denominator that ties everything together is human interaction, focus, prioritization and looking over the horizon. Mr. Dickson noted that we are blessed as a District.

Trustee Margi recalled last week when Bill Olien gave her a tour of the renovation underway at Murrieta Valley High School and wondered how they would be able to get all the work completed, but it came a long way and looks great.

Trustee Paul Diffley noted that there is a different feeling in the community today as the first day of school which includes lot of changes. He shared that there will be lots of things coming up and some will be difficult, however, what we are doing is investing in the 21st Century. Mr. Diffley stated that he feels confident moving forward with our staff and our students.
