STUDENT NONRESIDENT ADMISSION

Nonresident students may be accepted as out-of-district students in the schools under the following conditions:

- 1. Application is made prior to October 1 of the year being applied for.
- 2. Space is available and an appropriate program can be provided. Out-of-District students will not be admitted when class sizes of the application grade are greater than 20 students for grade level K-2, 22 for grade level 3-5 and 55 per grade level at grades 6-12.
- 3. Out-of-District students having been enrolled since September 2001 shall be granted waiver from condition 2 but must continue to meet all other conditions within this policy.
- 4. Students of employees of the school district will be waived from condition 2 but must continue to meet all other conditions within this policy.
- 5. Admission is subject to review of the educational records and administration of appropriate educational, physical, psychological and psychiatric examinations.
- 6. Admission acceptance is continuous for a single school until voluntary withdrawal, graduation, or expulsion. Re-admission must be applied for after a break in admission for any reason. Students who become nonresident during or between school years must apply for re-admission prior to October 1 of the subsequent school year.
- 7. Prior to enrollment, an official transcript must be received so that grades and credits can be evaluated before grade level placement.
- 8. A student must have attended Peyton School for at least two and one-half (2 ½) years, immediately prior to the time at which the honors are determined before being considered as a valedictorian or salutatorian.
- 9. It is a privilege and not a right to be granted admission as an out-of-district student. This privilege can be revoked at the Board of Education's discretion.
- 10. Admission is probationary, subject to periodic review and must be re-approved annually. At the end of the first semester, the principal will complete a review of the non-resident student's academic and behavior record. Students not performing at an acceptable level will be placed on a remediation plan for the second semester. At the end of the second semester, the principal will recommend future admission of the student to the Board based on the results of the remediation plan.
- 11. A student who is a senior in good standing may be allowed to complete his/her education at Peyton School District even if circumstances require him/her to reside outside of the district boundaries provided, however, that out-of-district enrollment application is made prior to October 1st.
- 12. Letters by the parents and host family are to be received by the school regarding housing arrangements within district, if student is to reside within the District.
- 13. Transportation will only be provided on a space available basis and if the student meets the bus on its normal route.

- 14. Subject to the qualifications in 1,2,3,4,5,6,7, and 8 above, students who are resident of nations other than the United States may be admitted without payment of tuition under recognized foreign student exchange programs, in which students are accepted, on an equivalent basis in foreign countries.
- 15. Nonresident preschool students will be charged \$70.00 per month for instructional services.

The superintendent shall present all nonresident applicants to the Board of Education at the next regular meeting following the application.

Recommendations of the superintendent shall be based on the District's policy. The principal shall not permit out-of-district pupils to enroll until the approval or disapproval of the Board of Education.
