8.2. Administration Plan at Gardner School

Superintendent Moore discussed a plan to assign the position of 0.5 intervention-ist/0.5 TOSA position to Pamela Levie; salary will be covered from Title 1 funds. The only duties at this position that Pamela is not qualified to administer are suspensions and expulsions. She will also train for evaluations. In cases of suspension or expulsion. Principal George Purnell will travel to Gardner School.

8.3. Importance of Generating Revenue for Immediate and Future District Needs

Superintendent Moore discussed an article that he wrote for the newspaper. He also discussed the need for revenue so that we can attract and keep teachers in the district. Superintendent Moore and board members discussed the community forum on August 11, 2015, and decided to invite commissioners and state legislators.

8.4. Staff Hiring

Superintendent Moore discussed upcoming interviews for Peakview School principal, and current job opening at Gardner School has an opening for the cook position, John Mall High School has no openings at this time, and Peakview School has the following positions open: SPED teacher, 4th grade teacher, 6th grade teacher, P.E. teacher, and one paraprofessional.

Gary Vigil reported that Unit 73, a 1988 Chevy pickup, needs an engine and is not worth fixing. He asked that the district deem this pickup as surplus and put an ad in the newspaper for bids. He said that, if the bids are not more than it is worth for scrap, the district will just scrap the pickup.
