PUBLIC HEARING

- I. CALL TO ORDER: Marcarlo Roanhorse called the public hearing to order at 6:01 p.m.
- II. REVIEW OF FY'2022-23 PROPOSED EXPENDITURE BUDGET. Henrietta Keyannie, Business Services Director provided the FY'2022-23 Proposed Expenditure Budget. Ms. Keyannie stated that the budget ADM (Average Daily Membership) was 1087.041 for this budget. Ms. Keyannie went over the Revenue Control Limit, and Estimated Budget Balance Carry Forward. She stated that the last net change is \$199,862.00 increase which the legislature has increased. Ms. Keyannie went over the District Additional Assistance which has decreased by \$62,701.00 which is estimated. Ms. Keyannie provided the Summary General Ledger Budget. Ms. James stated that even though the budget preliminary is being adopted it is not finalized until the state department makes possible final changes or increases. Mrs. Begay asked about the decrease in the ADM and asked about students still registering for this year. Ms. Keyannie stated that the ADM is based on the ADM that is done in May.

- IV. CLOSE PUBLIC HEARING: Mr. Roanhorse closed the public hearing at 6:13 p.m.

Mr. Roanhorse stated that the backpack policy should be reviewed because through his experience the mesh bags are really big for small children. He stated that maybe it should state that it is recommended and not required. Mrs. Gorman agrees that the mesh bags are too big for the pre-k students and most of the time, the students do not need the bags as they bring home their homework in a drawstring bag. Dr. Dobias stated that if they recommend it for pre-k, then they should waive the mesh bags for the entire building. Mrs. Begay agrees with Mr. Roanhorse and Mrs. Gorman that mesh bags are recommended and not required. She would like the get parents input on the item. Mr. Roanhorse recommends striking out the 1st sentence, under the 1st paragraph under BACKPACKS: Please provide your child with mesh/clear backpack big enough to hold a folder with his/her name on it; and to strike out the 3rd paragraph: For the protection of students and staff, ALL Bags in G.U.S.D. schools are required to completely be mesh or clear. If a solid bag is found to be in the possession of a student, the bag will be confiscated. If there is a reasonable suspicion that a search of the backpack would reveal evidence of a violation of a school rule or law, the bag will be subject to search. Parent pick-up will be required for all confiscated bags. Additionally, the district will not be liable for any loss, damage, or theft of any confiscated bags or items in the bag. Mrs. Begay accepts the recommendation for strike-outs in the policy.

Ms. James clarified that she did not accept the resignation because there were materials in the board packet where there were concerns raised and it is at the particular school where there were other issues and other personnel who resigned with concerns and this resignation is bringing up a lot of concerns which she feels need to be addressed. Mrs. Begay stated that there were some calls to the public and comments made about issues and concerns with staff within the different schools and was wondering if these concerns and issues concerning staff before they decide to resign are being addressed at each school and she is concerned because the district needs teachers. If there is concerns they need to be addressed which is why there is building Principals and the Superintendent. She feels like there are concerns, but no reports on whether these concerns are being addressed or not. She wants to know what is going on. Mrs. Gorman has the same concerns as Ms. James and Mrs. Begay because the teacher they are discussing is an excellent teacher. She stated that if there is a problem they need to be addressed. What are we going to do if we continue to lose more teachers? They should be working with Human Resources. Mr. Roanhorse made a substitute motion to table the item for further review of the matter, second by Ms. Judy James.

Dr. Dobias stated that Ms. Yazzie is leaving for an opportunity to make more money and that she wrote a nice resignation letter where there was no retaliation. Mrs. Begay agrees with Mrs. Gorman. She stated that in the past, they have asked about the exit interviews about why staff members are leaving the district. She stated that if they are leaving for their own personal reasons that is ok, but if there is a concern, then the board needs to know. They should be addressed, resolved and not swept under the rug. Mr. Roanhorse stated that it is very unfortunate that the district is losing staff members. Ms. Pete stated that she takes exit interviews very seriously and have given the information to the board during a previous work study session. She stated that she does not want to hold anyone back if they are trying to improve themselves even if that means that they decide to leave the district. She stated that all of these issues have been addressed to the T with the assistance of legal counsel. Mrs. Gorman stated that they are not stating that Ms. Pete is not responsible for this, however, she feels the issues should be resolved at the school level and is a leadership issue.
