Minneapolis Licensure Pathways

Minneapolis Teacher Residency

- Open to unlicensed ESP or MPS partner who has a BA
- Leads to a Master's degree in Education from St. Thomas
- Leads to a license in either K-12 ABS Special education or K-6 Elementary Education (general ed)
- Residents co-teach alongside a licensed cooperating teacher during the full year of the program

Teacher licensure Pathways Quick Overview

MPS Academy (MPS-A)

- Open to unlicensed ESP and Tier
 1 or 2 teacher who has a BA
- A licensed teacher who is interested in getting an additional license in special education
- Leads to license in K-12 ABS Special Education.
- Candidates are teacher of record supported by cooperating teacher, PAR Mentor, Site Administration, and Content Leads.

- Create accelerated pathways to teaching for our high-quality MPS employees
- Diversify our teaching workforce so our students can see themselves in their teachers
- Close the opportunity gap for our students through growing members of our community to become highly effective teachers for the MPS context.

Why?



The ABS license allows a candidates to work with students with mild to moderate needs across multiple disability areas from Kindergarten through age 21 in the areas of: ➤ Autism Spectrum Disorders (ASD)

> Developmental Cognitive Disability (DCD)

Emotional Behavioral Disorders (EBD)

 \succ Other Health Disorders (OHD)

Specific Learning Disabilities (SLD)

Academic Behavioral Strategist (ABS) License







The Minneapolis Elementary and Special Education Teacher Residency Program

A partnership with the University of St. Thomas



Eligibility Requirements

You are eligible to apply if you:

- ✤ Are currently employed by MPS or a community partner
- Will have completed and have a conferred bachelor's degree from regionally accredited university
- ✤ Are seeking your **initial** teaching license

We strongly encourage BIPOC and multilingual candidates to apply.

The final cohort will include up to 15 residents in the ABS track and up to 10 in the Elementary track.







K-6 elementary Education License

- Teach in Kindergarten 6th grade in all general education settings
- Minnesota license standards also require the following allied
 - courses:
 - TEGR 640 Teaching Math with Conceptual Understanding P-12 offered in Summer for Elem Cohort
 - > Math XXX College-Level Math Elective
 - > BIOL XXX Lab Science: Life Science (e.g, Biol 101)
 - > CHEM or PHYS: Lab Science: Physical Sc (e.g CHEM or PHYS 101)
 - ➢ GEOL XXX: Lab Science: Earth-Space (eg., GEOL 111)
- St. Thomas advisor will meet with you and review your transcript to determine what courses you need and suggestions of where to take these courses
- All residents will receive 1:1 advising each semester; test support, financial aid office, and weekly communication







How is this program different than traditional teacher prep?

- Earn Masters of Education degree and your teaching license in Special Education-Academic and Behavioral Strategist (ABS) or K-6 Elementary Education
- 15 month program starting end of May 2023 and ending August 2024
- Continue to work for MPS in Resident position.
 - Co-teach four days per week with a highly effective Cooperating teacher.
- Take graduate level coursework through the University of St. Thomas (most classes takes place during the day)







Program Schedule at a Glance

Summer 2023 (late May - late August)	 Work in MPS Summer Session Take Coursework Monday-Thursday for 9 weeks as an MPS cohort
August 2022- June 2024	 Co-teach with a highly effective Cooperating teacher four days a week Take coursework one day a week in a cohort model
Summer 2024	 Finish licensure and Master's degree coursework online







Program Costs and Benefits

COSTS

- > Tuition is \$660/credit, or a total of \$22,440
- Miscellaneous Fees ~\$1,000 (teacher licensure application, etc.)

✤ BENEFITS

- Earn approximately \$31,500 from MPS during residency year and are eligible for district benefits
- Increase your earning potential. A first year teacher with a master's degree makes \$53,000+







Tuition Support - Grant Funding for Special Ed Residents

Minnesota Department of Education (MDE) Grow Your Own Grant

MPS has received the GYO Grant for tuition support for the 21-22 school year and beyond for the **Special Education cohort**. The parameters of the grant say that:

- ◆ 80% of the funds must go to support BIPOC educators
- 20% can go to support white educators

Given these parameters, we anticipate being able to **fully cover** tuition for our BIPOC participants in the ABS pathway and **partially cover** tuition for white residents. Exact numbers for white residents TBD but we anticipate potentially 50% of tuition covered for white residents in the ABS track. More exact numbers will be known after the final cohort is chosen.

Tuition Support - Potential Grant Funding for Elementary Residents

Minnesota Department of Education (MDE) Grow Your Own Grant

MPS will be applying for the GYO Grant for tuition support for our Elementary track. Similar to the special ed grant, the parameters of the grant say that:

- 80% of the funds must go to support BIPOC educators
- 20% can go to support white educators

We do not yet know if we will receive funds from this grant ask. **Therefore we can not guarantee any tuition support for participants in the Elementary track as this time.** We should know if we receive funding this winter. We also plan to look at alternate grant possibilities.

Tuition Support - General

Tuition is \$660/credit, or a total of \$22,440

- All MSTR residents will receive up to \$1,000 scholarship from St Thomas
- May apply for Student Teacher Scholarships from state up to \$7,500 depending on state funds
- Support in applying for federal financial aid (FAFSA) and loans through UST financial aid office
- Federal Loan Forgiveness up to \$17,500 for special education and \$5,000 for elementary
 - \succ Must work in a high need school for 5 years to qualify







Benefits of the Teacher Residency program

- Continued employment with MPS as a Resident
- Reduced credits for license from University of St. Thomas
- All coursework is designed to prepare Residents be successful Minneapolis Public Schools teachers
- **Residents receive support around:**
 - Passing Minnesota Teacher Licensure Exams and completing requirements for Minnesota teaching license
 - > Preparing resumes and interviewing for teaching positions
- Guaranteed a position with MPS after residency year
 - Residents are asked to make a 3 year commitment to teach in MPS and will be supported by a PAR mentor and Human Resources.







MPS Academy

The ABS Licensure Pathway Program is a jobembedded preparation program that offers the opportunity for participants to work on a Tier 2 teaching license for one year to obtain their Special Education ABS license.




ABS Licensure Pathway Highlights

- Field experience while attending the program
- ✤ 6 hours of class per week
- ✤ No tuition cost
- Modules taught through a social, emotional, and cultural lens
- Attain a Tier 3 Academic Behavioral Strategist (ABS) MN license
- Bachelor's degree required
- Candidates receive support from a cooperating teacher, PAR mentor, content leads, and site administration

- Is seeking an initial license in either K-12 ABS Special education or K-6 Elementary Education (general ed)
- Wants to co-teach alongside a licensed cooperating teacher during the program

An ESP who has a BA and:

- Is ready to serve independently as the teacher of record during the program
- Is seeking ABS licensure
