III. ACTION ITEMs

- A. Presentation, Discussion and possible vote on approval of Certified Staff 2021-2022 salary increase. The Teachers (Certified Staff) salary schedule needed to be updated after a couple years just adding dollar amounts to existing salaries. Also, we have made adjustments to the starting pay to help attract new teachers to Naco ESD. I recommend this with the information coming out about possible/probable funding and the good possibility that if there is funding beyond the projected increase, we could add monies to the salary schedule at that time. Moved by Romero seconded by Walker-Garner Ayes 3- 0 Nays
- B. Presentation, Discussion and vote on approving the recommendation of approving the list of classified staff Para-professionals and Kitchen staff to offer contracts for next year. Moved by Olmos seconded by Romero Ayes 3- 0 Nays
- C. Presentation, Discussion and possible vote on classified pay scale increase for the 2021-2022 school year with the acknowledgement that we had an increase to the minimum wage on January 1, 2021 and those salaries that were directly affected by that increase have been modified less and we will have another increase coming in January of 2022. Keep on mind we also have the increase in benefits of over 550 per person next year. Moved by Romero seconded by Olmos Ayes 3- 0 Nays
- D. Presentation, Discussion and possible vote on a Continuing Resolution to allow the county to invest funds in the ways the County Treasurer Office feels is most beneficial. The resolution is in the School Boards packet. Moved by Olmos seconded by Romero Ayes 3- 0 Nays
- E. Presentation, Discussion and possible vote on the hiring of Rebicres A. Abardo as our new 3rd Grade teacher. I recommend we hire her on Step 7 BA lane at a salary of \$35,960. She brings with her 20 teaching years of experience, 3 in Arizona and the experience of helping turn her school around. The committee was made up of Mayclin, Martan, Dietrich and Mott. Moved by Olmos seconded by Walker-Garner Ayes 3- 0 Nays
- F. Presentation, Discussion and possible vote on a retention bonus plan. We also have allotted for the up to a 420 increase in the benefit package and a 580.00 retention bonuses for all employees who take school insurance. I am recommending a \$500 bonus for any part time employees who do not receive insurance from the district's plans offered. Moved by Romero seconded by Olmos Ayes 3- 0 Nays
- G. Presentation, Discussion and possible vote on approving Fund 12 and Fund 13 amounts for the 301 PPP performance pay bonuses for Teaching staff. The entire Teaching staff may qualify for Fund 012 for a total of \$2,400.00 per person. (last year was \$1,950 for each fund) Fund 013 is for \$2,800 but we are awaiting the finishing of the 7 categories to see who qualifies. Those teachers will be brought to the board at the May meeting for the 013-fund bonus as long as the results come to us in a timely manner in mid-May. Moved by Olmos seconded by Romero Ayes 3- 0 Nays
