- H. **We will have Summer School for 10 days over 3 weeks for grades 1-5 and 1 full week 5 days from 8 to 4 the first week after school for Middle School.** Middle School will be only Credit Recovery. We also hope to offer for everyone who is interested science activity times as many days as we can during our 10 days of summer school either in the morning or afternoon. The U of A has said they will come down so we are waiting for confirmation of days and times, but our Middle School loved the science Activities they brought to Naco last month.
