IV. ACTION ITEMs

A. Presentation, Discussion and possible vote on Changing the School Calendar for the 2021-2022 school year with the change being adding a full teacher day of professional Development on Monday, July 26th and having the day of workshop

- scheduled for January 3rd off-with no school or work. **Moved by Romero seconded by Olmos Ayes 3- 0 Nays**
- B. Presentation, Discussion and possible vote on approving the ESSER II Budget. This budgeted amount is \$ 488,092.20. Moved by Walker-Garner seconded by Romero Ayes 3-0 Nays
- C. Presentation, Discussion and possible vote on approving Fund 12 and Fund 13 amounts for the 301 PPP performance pay bonuses for staff. The staff except for 4 Teachers qualified for Fund 012 for a total of \$2,400.00 per person. Fund 013 is for the amount of \$2,800. Almost all teachers qualified for the part of the 301 PPP. Mr. Mayclin can present the names of those not getting the payments or those who did, that would be done in a closed session. Moved by Olmos seconded by Walker-Garner Ayes 3- 0 Nays
- D. Presentation, Discussion and possible vote on hiring of Margo Dietrich as ELL teacher @ Step 3 for \$33,800. She is coming in with 7 total years' experience but 1 year with ELL work, so we are starting her on Step 3. This salary also meets the stipulations and finances in the SEI grant to allow us 2 teachers under that grant for next year. Moved by Romero seconded by Walker-Garner Ayes 3- 0 Nays Board wanted to welcome Margo to the staff.
- E. Presentation, Discussion and possible vote on Hiring 2 Part time 16 to 18-year-old students to work with custodians to help moving furniture, board, etc. We would have them work from 7:30-11:30 each morning Monday –Thursday. They will be old enough to help with lawn care if needed and with the physical moving of furniture and white & cork board in the classrooms. We would not use them on Fridays unless an unforeseen need comes up. They would receive minimum wage and work from about the end of May until July 9th or 16th, whatever is determined by the amount of work we need to accomplish. We would put this on the website immediately and post until filled. They will need to 16 for us to hire them. Moved by Walker-Garner seconded by Romero Ayes 3- 0 Nays
- F. Presentation, Discussion and possible vote on the Summer Office Hours from 7:00-3:30 Monday through Thursday. There will be no secretary or office help on Fridays. Summer Custodial hours will be 7:00-3:45 Monday through Thursday and Fridays from 7:00-11:30. Moved by Walker-Garner seconded by Romero Ayes 3- 0 Nays
- G. Presentation, Discussion and possible vote on Robert Zavala as the School Resource Officer for the 2021-2022 School year. His salary and benefits are covered by the state Safety Grant and the state has funded this position for the next 2 years for \$ 75,100.00 to cover the expenses for this position. The salary as per grant will be \$ 62,552.00. There will be no cost to the district to completely cover the FICA and taxes paid to the state and federal government. That is covered in the grant and this grant is good for 2 years and then we will need to reapply. His salary may be paid by the district or the Sheriff's office we are working

out an IGA with the Cochise County Sheriff's office. Moved by Olmos seconded by Romero Ayes 3- 0 Nays. The School Board would like to Welcome to the staff at Naco.

- H. Presentation, Discussion and possible vote on approving the switching over form Fluorescent Lighting to LED lighting, the actual discount will be a little over 10% but the entire project will be completed and cost less than \$35,000 and we will pay for this using either the ESSER II funding or the ARP (ESSER III) funding. Moved by Romero seconded by Walker-Garner Ayes 3- 0 Nays
- I. Presentation, Discussion and vote on closing the Revolving Account at Washington Federal. We have used this account for well over a year and have continued to pay \$ 5.00 a month in service charges. This \$ 60.00 a year we will save. Moved by Walker-Garner seconded by Olmos Ayes 3- 0 Nays
