This is the Policy Advisory # 670- Policy GCCA and we are looking at action regarding updating and expanding policy GCCA. (The board previously approved the granting of sick days per the policy to 10 for 10-month employees and 12 to 12-month employees.) The portion we will finalize will be the sick leave buy back portion which was presented to the staff and almost 100% of the feedback favored option 2 which was the extension of the wording in the policy we have in place. **Moved to approve option #2 by Romero seconded by Walker-Garner Ayes 3- 0 Nays**

B. Presentation, Discussion, and possible vote on approving the increase in pay for any necessary staff and recognizing and putting into place the minimum wage pay of \$12.15 per hour as of January 1, 2021. The Hourly wage schedule will show increases for those areas that are under the new minimum wage amount but will not show increases for any other areas, the schedule for wages will be addressed following the school year dependent on the budget passed by the legislature. C. Presentation, Discussion, and possible vote on 301 Performance Pay Plan for Teachers for the 2020-2021 School Year. It is the recommendation of the Superintendent to approve this plan with the thought and modifications included to take in effect the possible disruptions to this school year for our students and staff and find ways to help the staff improve professionally and build a stronger team at Naco ESD Moved by Walker-Garner seconded by Romero Ayes 3- 0 Nays #23.
