5. APPROVAL OF MINUTES

Upon a motion by Commissioner Nardozi and duly seconded by Commissioner Harvey, it was voted unanimously to approve the minutes of the Regular Meeting of December 17, 2020 and Workshop of January 7, 2021.

6. PUBLIC ADDRESSES THE BOARD

The public was offered the opportunity to address the Board during the public portion of the meeting by calling 1-701-802-5303 with access code 7755337 between 6:00 and 6:15 p.m.

Upon a motion by Commissioner Sweeney and duly seconded by Commissioner Harvey, it was voted unanimously to suspend the regular order of business at 6:36 p.m. to allow the public to address the Board.

Tyler Wrenn of Waterbury spoke about how cities and schools harm students more than help. He commented on cops in schools. Commented on the Thoughtexchange and the Roundtable. Asked that the MOU on School Resource Officers not be voted on tonight.

Isaac Bloodworth of Waterbury is concerned with the process used to create the MOU and asked that it be tabled.

Miranda Valerio of 14 Standrod Avenue, Waterbury, is concerned about the process used to create the MOU with the Police Department and asked that it be tabled.

Joy Meikle of 14 Standrod Avenue, Waterbury, believes in redirection of resources and must end the school to prison pipeline. Stated no community input was sought and does not support the racist process used or the MOU.

Rob Goodrich of 14 Standrod Avenue, Waterbury, requested the Board remove item 10.1 from the Consent Calendar and table the agreement. Feels the agreement is poorly designed and informed the Board of what they're required to do.

Julio Olivencia of 14 Standrod Avenue, Waterbury, feels it's undemocratic to vote on the item and that it should be tabled.

Michaela Barratt of 137 Woodlawn Terrace, Waterbury and a Kennedy High School student, asked that the MOU be pulled from the agenda and that the Board get opinions from the public.

Christian Acevedo of Waterbury and a Crosby High School student, spoke about the school to prison pipeline and statistics from other districts. Suggested developing a focus group. Asked to not let black and brown students become statistics.

Katherine Jones of 14 Standrod Avenue, Waterbury, stated the Board voting on the MOU without any democratic process is shameful.

Christi Ollero of 25 Oldham Avenue, Waterbury and a graduate of Kennedy High School, spoke about Connecticut not meeting the counselor to student ratio and the lack of social and emotional services in the schools. Stated police presence in school is racially biased.

Mahnue Sahn of 147 Manchester Avenue, Waterbury, stated that Waterbury has had the most in school arrests in the State. Asked that the MOU be removed and issues be addressed. If you have any respect work for the betterment of the education system, remove and address issues pertaining to more student and parent representation and the student to prison pipeline.

Franchesca Araujo of Waterbury asked how the Board could vote on an MOU with no public input and stated she was traumatized by policing in Kennedy High School.

Maytae Harge of 21 Buckingham Street of Waterbury and a product of Waterbury Public Education. She is livid an MOU would be voted on and discussed in a private meeting and why after six years is it so urgent. Stated the MOU is not about the safety of the children. This discussion should have been held a long time ago.

Tashieka Sangster of Waterbury and a former Waterbury Career Academy student, find the process alarming. No students, parents, or community members were included. Seems like a direct attack on the efforts of protesters this past summer. We should allocate funds to train proper professionals not police officers.

Clancy Emanuel of 14 Standrod Avenue, Waterbury, stated it seems like no one is paying attention. The white members need to step up. If you do not take this MOU off the consent calendar you are racist and upholding white supremacy.

Ireland Gilmore of 48 Buena Vista Circle, Waterbury, concerned with the process the MOU was developed. Asked us not to forget the change 2020 brought to this world. Spoke about newspaper articles of students' arrest and Waterbury was the focus. Requested item 10.1 be taken off and tabled. She thanked Commissioner Harvey for asking for community involvement.

Liliana Oliveira of 182 Edgewood Avenue, Waterbury and a graduate of Kennedy High School, wanted to express concerns for the lack of transparency and complete disregard of community input, the MOU is harmful to black and brown students, and doesn't address the structural issues. Asked that the vote be cancelled on the MOU.

Kerri Mastrantuono of 131 Birchwood Street, Waterbury, and a Kennedy High School graduate, stated the MOU does not outline accountability measures of staff who violate the rights of students. Asked if Waterbury educators receive de-escalation training and there is a City-wide Crisis Intervention Plan for school. Presence of law enforcement in schools often place students on high alert. Asked to table the MOU and listen to the voices of black and brown

F. Alam of 46 Procter Street, Waterbury, hopes the Board is listening, people are talking about their trauma and experiences. In 2018/2019 over 200 students were arrested. Black and brown communities are impacted the most, low income communities are impacted the most. Suggested tabling the MOU and get transparency and the district provides accurate data about the arrests that occurred and how many staff and officers were reprimanded for arrests without cause.

Karolina Ksiazek of Waterbury, educator and outreach worker, concerned with process of the MOU. It is the Board's responsibility to represent all students and its decisions impact people's lives. Pull the MOU from the agenda and allow participation in the process. Allow yourselves to open your heart and truly listen to stories of those who were impacted.

Eric Ezavier of 31 Silver Street, Waterbury, stated a focus on police reform and de-escalation is needed before you think of an MOU.

Donald Streater of 183 Transit Street, Waterbury, is an African American male and it's a disservice to the community to provide more funding to the police, we should remove police from schools and postpone your decision on the MOU.

Ala Ochumare of 14 Standrod Avenue, Waterbury stated they're showing you as a community that you do not vote on this and to allow the community and residents identify what we want and what we need from you.

Argenis Herrera of Waterbury and a product of the Waterbury Public Schools, asked why isn't the MOU addressing the school to prison pipeline in Waterbury. Asked the MOU to be pulled and allow participation in the process.

Upon a motion by Commissioner Sweeney and duly seconded by Commissioner Stango, it was voted unanimously to return to the regular order of business at 7:59 p.m.
