The opening prayer was given by Dr. Keith Davis.

A review of Sheffield City Schools mission, vision, and belief statements

A motion to adopt the agenda for the August 23, 2021, meeting of the Board was made by Mrs. Ruggles, seconded by Mrs. Scales, and passed by the Board unanimously.

A motion to approve minutes of the July 26, 2021 regular meeting and August 2, August 6, and August 12, 2021, special called meetings of the Board was made by Mrs. Scales, seconded by Mr. Nix, and passed by the Board unanimously.

Board members received copies of the monthly financial report for the month of July 2021.

Superintendent Davis presented Board members with copies of disbursements for the month of July 2021 and recommended they be approved. The motion to approve the recommendation was made by Mrs. Ruggles, seconded by Mrs. Scales, and passed by the Board unanimously.
