CHARLESTON BOARD OF EDUCATION REGULAR MEETING March 26, 2013

The Charleston Board of Education met in regular session on Tuesday, March 26, 2013 at 6:00 p.m. in the Fine Arts Building. A brief Pre-Calculus presentation was provided by Mrs. Carol Terry and three students.

The meeting was called to order at 6:02 p.m. by Mr. Trey Gage.

A motion was made by Mrs. Michele Schmitz and seconded by Mr. Joel McDonald to approve the 2013-14 school calendar as presented. Motion carried 5-0.

A motion was made by Mr. Brian Verkamp and seconded by Mrs. Michele Schmitz to approve the consent agenda as listed. Motion carried 5-0.

(60 Chromebooks and 60 ACAD LIC + SUP) with purchase contingent upon CDWG providing evidence of an approved Arkansas purchasing contract. Motion carried 5-0.
