MINUTES REGULAR GOVERNING BOARD MEETING December 9th, 2013

1. The meeting was called to order at 6:35 PM.
2. Jo Burke made the motion to adopt the Agenda. The motion was seconded Jackie Harshman and the Agenda was adopted with a unanimous vote.
3. Information Items
 - a. Karin informed the Board Members that two 8th grade students and herself did a radio add encouraging people around the community to donate their AZ state tax credit to Beaver Creek School.
 - b. There will be a Executive Session before the next Board Meeting at 5:30 regarding the Annual Evaluation of the Superintendent and possible renewal of contract.
 - c. Karen DuFresne, Karin Ward and Lynn Leonard attended the ASBA/ASA Legislative Conference. Karen DuFresne spoke about the end of full time Kindergarten, trends in the work force and how Arizona does not create ways to generate funds for Education.
 - d. Annual ABEC Legislative Connection on January 15th. Karen DeFresne and Karin Ward to attend.
 - e. Jeff Clarke did a presentation on Galileo for student learning. The Members of the Board joined Mr. Clarke and a student in his classroom, Mr. Clarke showed the Board Members how everything worked. Mr. Clarke gave the Board Members a demonstration on the Smart Board and provided information to them about how great the technology is and how much it can help students. Students can access their assignments from home and complete them during the weekend if they wanted to.
 - f. Lynn Leonard informed the Board Members that there will be a change in the district Health Care Plan. The Health Care Plan will now cover their clients when they are out of state.
 - g. Numbers and Budget implications; 40 day snap shot. Beaver Creek School lost 24 students which means the School loses around 108,000 dollars.
